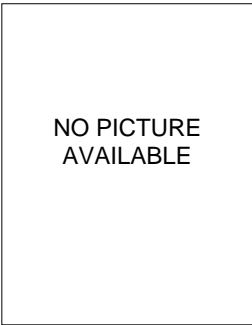

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)
 EVENT #16807 "BWC INCIDENT" IN SUMMARY, NAEEM COKER (ARRESTEE) WAS THE DRIVER OF THE ABOVE LISTED VEHICLE, WHICH A LEADS INQUIRY BY BEAT 652 REVEALED WAS STOLEN. BEAT 652 BEGAN TO FOLLOW THE VEHICLE, AT WHICH POINT THE ARRESTEE FLED EVENTUALLY LOSING CONTROL OF THE VEHICLE AND CRASHING INTO A PARKED VEHICLE. THE ARRESTEE EXITED THE VEHICLE BEFORE FLEEING ON FOOT AS POLICE HELICOPTER 1 MONITORED HIS MOVEMENTS. P.O. SCANLON #15504 PURSUED THE ARRESTEE ON FOOT AND ATTEMPTED TO PLACE HIM IN CUSTODY, AT WHICH POINT, IN AN ATTEMPT TO DEFEAT ARREST, THE ARRESTEE ATTEMPTED TO DISARM THE OFFICER BY STRIKING DOWNWARD ON THE OFFICER'S SERVICE WEAPON WITH A CLOSED FIST. THE ARRESTEE MADE GOOD ON HIS ESCAPE BUT AFTER A BRIEF FOOT CHASE, WAS CAPTURED AND PLACED INTO CUSTODY AND TRANSPORTED TO AREA CENTRAL BY BEAT 624R FOR FURTHER INVESTIGATION. A LEADS INQUIRY REVEALED THE ARRESTEE HAS A SERVICEABLE WARRANT FOR ASSAULT OUT OF MCCLEAN COUNTY IL (HOLD #B24716). ARRESTEE IS A DOCUMENTED GANG MEMBER (GANGSTER DISCIPLE - UNPLUGGED THUG FACTION) AND A CONVICTED FELON (PREVIOUS RESIST PEACE OFFICER CONVICTION). ARRESTEE IS NOT ON PAROLE/PROBATION; NO INVESTIGATIVE ALERTS; NO GIPP. ARRESTEE HAS \$130.75 USC ON HIS PERSON AND PRISONER'S PERSONAL PROPERTY INVENTORIED - #14332479 AND 14332480.
