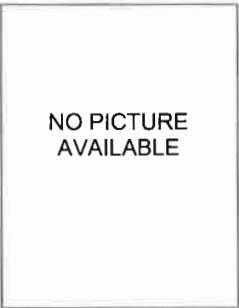

Name check revealed above arrestee to be on parole, warrant issued by IDOC, warrant #CP1901730. Arrestee is a documented gangster disciple. Arrestee not on trapp.
