 EVENT # 16680 IN SUMMARY, UNIT 1 WAS CURBED FOR A TRAFFIC VIOLATION AT 43RD AND BERKELEY BY 263D. A NAME CHECK VIA OEMC OF THE DRIVER REVEALED A SUSPENDED DRIVERS LICENSE. DURING THE COURSE OF THE INVESTIGATION THE DRIVER SPED OFF WESTBOUND ON 43RD STREET WHILE OFFICERS WERE STANDING AT HIS VEHICLE. THE OFFICERS THEN OBSERVED THE VEHICLE LOSE CONTROL AND HIT A TRAFFIC SIGNAL LIGHT POLE. DRIVER WAS PRONOUNCED DEAD ON SCENE BY UNIVERSITY OF CHICAGO DOCTOR ROGERS AT 12:00AM. CFD AMB #57 TRANSPORTED THE DRIVER TO UNIVERSITY OF CHICAGO. CHICAGO FIRE DEPARTMENT VEHICLES ON SCENE: AMB 57, ENGINE 45, TRUCK 15, FIRE TRUCK 5 AND 5A ON SCENE.
