EVENT #16680. THIS IS A BWC INCIDENT, BWC REVIEWED PRIOR TO THIS REPORT. IN SUMMARY, R/OS WERE ON DIRECTIVE PATROL TRAVELING EASTBOUND ON 43RD ST WHEN THEY OBSERVED A TRUCK TURNING EASTBOUND ON 43RD ST FROM SAINT LAWRENCE AVE. SAID VEHICLE WAS OBSERVED TRAVELING AT A HIGH RATE OF SPEED EASTBOUND ON 43RD ST. R/OS FOLLOWED SAID VEHICLE TO OBTAIN A CLEAR VIEW OF SUBJECT'S VEHICLE LICENSE PLATE. SAID VEHICLE CONTINUED TO TRAVEL EASTBOUND ON 43RD ST AND FAILED TO SIGNAL WHEN IT TURNED SOUTHBOUND ON ELLIS ST. SAID VEHICLE THEN FAILED TO SIGNAL AGAIN WHEN IT TURNED LEFT TO GO EASTBOUND ON 44TH ST. SAID VEHICLE FAILED TO SIGNAL ONCE AGAIN WHEN IT TURNED LEFT ON BERKELEY. R/OS CURBED SAID VEHICLE AT APPROXIMATELY 4300 S BERKELEY AVE FOR SAID TRAFFIC VIOLATIONS. R/OS APPROACHED SAID VEHICLE AND SPOKE WITH DRIVER OF SAID VEHICLE NOW KNOWN AS REGINALD MADISON(OFFENDER). P.O JURADO #9392 ASKED REGINALD MADISON(OFFENDER) FOR HIS DRIVER'S LICENSE WHICH REGINALD MADISON(OFFENDER) STATED NOT VERBATIM "I'M SUSPENDED, I'M FIGHTING A DUI CASE" . WHILE TALKING TO REGINALD MADISON(OFFENDER) P.O JURADO #9392 SMELLED AN ODOR OF BURNT CANNABIS EMANATING FROM THE INTERIOR OF SAID VEHICLE. P.O JURADO ASKED REGINALD MADISON(OFFENDER) IF THERE

WAS ANY CANNABIS INSIDE OF SAID VEHICLE AT WHICH TIME HE ADMITTED TO HAVING SMOKED EARLIER IN THE DAY. P.O NAJARRO #8518 WHILE STANDING ON THE PASSENGER SIDE OBSERVED A WATER BOTTLE CONTAINING A BROWN LIQUID SUBSTANCE WITH A LIME INSIDE OF IT, POSSIBLY BEING AN ALCOHOLIC BEVERAGE. DUE TO THE ODOR OF CANNABIS AND THE OFFENDER HAVING A SUSPENDED LICENSE, R/OS ASKED REGINALD MADISON(OFFENDER) TO EXIT HIS VEHICLE TO FURTHER INVESTIGATE. REGINALD MADISON(OFFENDER) BEGAN TO MOVE HIS HANDS BY HIS WAISTBAND AND FAILED TO FOLLOW P.O JURADO'S VERBAL COMMANDS TO EXIT SAID VEHICLE. DUE TO REGINALD MADISON'S (OFFENDER) SUDDEN MOVEMENTS AND NOT COMPLYING WITH P.O JURADO'S #9392 VERBAL COMMANDS TO EXIT SAID VEHICLE, P.O JURADO #9392 ATTEMPTED TO OPEN THE DRIVER'S SIDE DOOR. REGINALD MADISON(OFFENDER) THEN PLACED HIS VEHICLE IN DRIVE AND DROVE OFF WESTBOUND ON 43RD ST AT A HIGH RATE OF SPEED SCREECHING HIS TIRES AND ALMOST STRIKING A VEHICLE TRAVELING EASTBOUND ON 43RD ST. R/OS THEN WALKED TO THEIR PATROL VEHICLE AND NOTIFIED OEMC OF SAID VEHICLE TAKING OFF ON R/OS. R/OS PROCEEDED WESTBOUND ON 43RD ST TO RADIO THE DIRECTION OF SAID VEHICLE AND TO MAKE SURE FLEEING VEHICLE DID NOT STRIKE ANY OTHER VEHICLES. FROM A DISTANCE OF APPROXIMATELY ONE BLOCK AWAY, R/OS OBSERVED SAID VEHICLE LOSE CONTROL AND STRIKE A LIGHT POLE AT 4300 S. DREXEL BLVD REPORTED UNDER RD # JC-151607. R/OS PROCEEDED TO THE LOCATION OF ACCIDENT AND OBSERVED REGINALD MADISON(OFFENDER) UNRESPONSIVE SLOUCHED OVER TOWARDS THE FRONT PASSENGER SEAT. R/OS IMMEDIATELY REQUESTED EMS VIA OEMC. R/OS OBSERVED OFFENDER HOLDING A CLEAR KNOTTED BAG IN HIS RIGHT HAND AND P.O NAJARRO #8518 RECOVERED SAID BAG AND FOUND IT TO CONTAIN A CLEAR KNOTTED BAG CONTAINING 19 SMALL ZIPLOCK BAGS CONTAINING A WHITE POWDERY SUBSTANCE SUSPECT HEROIN AND 21 SMALL ZIPLOCK BAGS CONTAINING A WHITE ROCK LIKE SUBSTANCE SUSPECT CRACK-COCAINE (INV#14375356). CFD ON SCENE OBSERVED A HANDGUN ON THE DRIVER'S DOOR PANEL. P.O SUGGS #6174 RECOVERED A KODIAK DENALI, SEMI-AUTOMATIC, BARREL LENGTH 2.8, .380 CALIBER HANDGUN SERIAL# K00802 WHICH WAS REPORTED STOLEN OUT OF CLEVELAND, OHIO NIC# G4733498366 (IN#14375334). CFD #57 TRANSPORTED REGINALD MADISON(OFFENDER) TO UNIVERSITY OF CHICAGO HOSPITAL. REGINALD MADISON(OFFENDER) WAS PRONOUNCED AT 2359 HRS PER DR.
