NARRATIVE

EVENT #14755: THIS IS A BODY WORN CAMERA EVENT. FOOTAGE WAS VIEWED PRIOR TO WRITING THIS REPORT. IN SUMMARY, WHILE ON PATROL, R/O'S OBSERVED A VEHICLE BEARING TEMPORARY ILLINOIS LICENSE PLATE ( ) COMMIT A TRAFFIC VIOLATION WHEN THE DRIVER OF THE VEHICLE TURNED SOUTHBOUND ONTO INDIANA FROM 103RD ST. WITHOUT USING A TURN SIGNAL. R/O'S ACTIVATED EMERGENCY EQUIPMENT TO INITIATE A TRAFFIC STOP. AFTER THE VEHICLE TURNED WESTBOUND ONTO 103RD PLACE IT STOPPED TEMPORARILY. AFTER A FEW SECONDS THE VEHICLE DROVE OFF TURNING SOUTHBOUND ONTO MICHIGAN. R/O'S DEACTIVATED THEIR EMERGENCY EQUIPMENT AFTER THE DRIVER OF THE VEHICLE FAILED TO STOP AT THE STOP SIGN AT 105TH ST AND MICHIGAN. AFTER EXTINGUISHING THEIR EMERGENCY EQUIPMENT R/O'S ATTEMPTED TO KEEP THE VEHICLE WITHIN EYESIGHT. THE VEHICLE TRAVELED SOUTHBOUND ON MICHIGAN TURNING EASTBOUND ON 109TH STREET. THE VEHICLE THEN TURNED NORTHBOUND ONTO CALUMET BEFORE STRIKING ANOTHER VEHICLE AT THE CORNER OF 107TH AND CALUMET. THE VEHICLE CRASH WAS DOCUMENTED UNDER RD #JC172728. THERE WERE FOUR OCCUPANTS INSIDE THE VEHICLE AT THE TIME OF THE CRASH. ONE OF THE OCCUPANTS (NOW KNOWN AS ) WAS FALTALLY INJURED. WAS TAKEN TO ROSELAND HOSPITAL BY BEAT 4212 SGT. P. ORLANDO #2208. MOTHER (NOW KNOWN AS ) WHO WAS ALSO A PASSENGER IN THE VEHICLE WAS ALSO TAKEN TO ROSELAND HOSPITAL BY BEAT 566C. WAS PRONOUNCED AT ROSELAND HOSPITAL AT 2126 HRS (ME201901027). THE THIRD PASSENGER IN THE VEHICLE (NOW KNOWN AS ) WAS TAKEN TO CHRIST HOSPITAL VIA CFD AMBULANCE #29. THE DRIVER OF THE VEHICLE (NOW KNOWN AS DONELL DAVIS) WAS TAKEN INTO CUSTODY ON SCENE, AFTER HE WAS EXTRACTED FROM THE VEHICLE. AFTER DAVIS WAS DETAINED, HE INFORMED P.O. LUKE OPOKA #18952 THAT HE HAD A WEAPON UNDERNEATH THE DRIVER'S SEAT. P.O. OPOKA NOTIFIED HIS PARTNER P.O. THOMAS FENNEL #15220. P.O. FENNEL THEN RECOVERED FROM UNDERNEATH THE FRONT DRIVER'S SEAT (1) GLOCK, MODEL 19, SERIAL # , 9MM, SEMI-AUTOMATIC, BLACK FINISH, LOADED WITH 28 LIVE ROUNDS WITH 1 ROUND IN THE CHAMBER. DAVIS WAS TRANSPORTED TO THE 005TH DISTRICT BY BEAT 513R FOR FURTHER PROCESSING. OFFENDER DAVIS DOES NOT HAVE A VALID FOID CARD OR AN ILLINOIS CONCEALED CARRY LICENSE. DAVIS IS ALSO A CONVICTED FELON UNDER 17CR09751. GUN DESK NOTIFIED, CLEAR NOT REGISTERED, PER P.O. ARGUELLO #14239.
