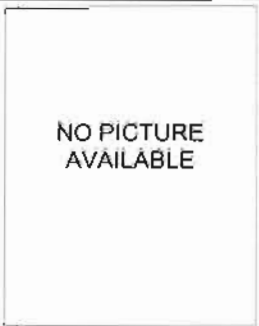

INCIDENT NARRATIVE

EVENT#05845. IN SUMMARY, WITH PRIOR KNOWLEDGE OF ABOVE VEHICLE TO BE STOLEN AND ABOVE ARRESTEE (WISE,KAYIN) TO BE THE DRIVER OF THE ABOVE STOLEN VEHICLE THAT FLED FROM A/O'S THE PREVIOUS DAY. A/O'S WERE ON PATROL IN THE 25TH DISTRICT AND OBSERVED ARRESTEE SITTING IN THE DRIVER SEAT OF THE ABOVE STOLEN VEHICLE WITH THE ENGINE RUNNING AT 4946 W. CONCORD IN THE ALLEY. A/O'S THEN APPROACHED THE ARRESTEE TO PLACE ARRESTEE IN CUSTODY. THE ARRESTEE THEN ACCELERATED HIS VEHICLE TOWARD A/O'S, AT WHICH TIME THE ARRESTEE STRUCK A/O ROLDAN WITH HIS VEHICLE. ARRESTEE THEN CONTINUED TO FLEE W/B IN THE NORTH ALLEY OF THE 4900 BLOCK OF W. CONCORD. ARRESTEE THEN STRUCK A PARKED VEHICLE THAT WAS OCCUPIED BY A WOMAN AND A [REDACTED] IN THE ALLEY. BEAT 2563E THEN ARRIVED ON SCENE. DURING WHICH TIME ARRESTEE ACCELERATED HIS VEHICLE PUSHING THE STILL OCCUPIED PARKED VEHICLE INTO A/O AMPARAN, PINNING A/O AMPARAN BETWEEN HIS SQUAD CAR AND PARKED VEHICLE. A/O'S REPEATEDLY GAVE VERBAL DIRECTION TO ARRESTEE TO STOP THE VEHICLE. THE ARRESTEE REFUSED TO OBEY A/O'S VERBAL COMMANDS AND CONTINUED TO ACCELERATE PUSHING THE PARKED VEHICLE FURTHER INTO A/O AMPARAN CAUSING ADDITIONAL INJURY TO A/O AMPARAN. AT WHICH TIME A/O AMPARAN FEARING FOR HIS LIFE DISCHARGED HIS DUTY WEAPON STRIKING ARRESTEE MULTIPLE TIMES. A/O'S REPEATEDLY ORDERED ABOVE ARRESTEE TO EXIT THE VEHICLE AND UNLOCK THE DOOR. ARRESTEE AGAIN REFUSED TO LISTEN TO A/O'S VERBAL DIRECTION. A/O ROLDAN THEN BROKE THE FRONT RIGHT PASSENGER SIDE WINDOW WITH HIS BATON. A/O'S WERE THEN ABLE TO REMOVE ARRESTEE FROM VEHICLE. ARRESTEE WAS TRANSPORTED BY CFD AMB 7 TO MT. SINAI HOSPITAL, BT 2563C ESCORTED ARRESTEE. WHILE AT MT. SINAI HOSPITAL ARRESTEE OVERHEARD CONVERSATION BETWEEN A/O'S LANG AND RAMOS THAT AN OFFICER WAS INJURED. ARRESTEE ASKED IN SUMMARY NOT VERBATIM "HOW BADLY HURT IS THE OFFICER I HIT." ARRESTEE WAS ABLE TO DESCRIBE A/O AMPARAN, AS ARRESTEE HAS KNOWN A/O AMPARAN FROM PREVIOUS ENCOUNTERS. WHEN A/O'S DISCLOSED THE SEVERITY OF THE OFFICER'S INJURIES THE ARRESTEE ASKED A/O'S LANG AND RAMOS "TO TELL THE OFFICER HE WAS SORRY". ET'S WHILE PROCESSING THE ABOVE STOLEN VEHICLE RECOVERED A .40 CALIBER HANDGUN ON THE FLOORBOARD NEXT TO THE DRIVER'S SEAT.
