EV#16848. **THIS IS A BWC INCIDENT** IN SUMMARY, R/O'S RESPONDED TO AN OEMC ASSIGNED JOB OF AN AUTO ACCIDENT AT THE ABOVE LOCATION. R/O'S SPOKE TO BT 4472 (SANDERS#17071 AND ARMSTRONG#14440) WHO RELATED THAT THEY OBSERVED DRIVER OF UNIT 1 TRAVELING W/B ON CHICAGO AVE USING A CELLPHONE. BT 4472 RELATED TO R/O'S THAT THEY ACTIVATED EMERGENCY EQUIPMENT EAST OF CICERO AVE ON CHICAGO AVE AND ABOVE VEHICLE (UNIT 1) PULLED OVER AT 4826 W CHICAGO. BT 4472 RELATED THAT BEFORE THEY STEPPED OUT OF THEIR VEHICLE UNIT 1 IMMEDIATELY FLED TRAVELING W/B ON CHICAGO AVE AND SHORTLY AFTER COLLIDED WITH UNIT 2, UTILITY POLE AND A FENCE. R/O'S OBSERVED AN M/1 (LATER KNOWN AS OCCUPANT OF UNIT 1) LAYING FACE UP IN THE STREET (CHICAGO AVE) BLEEDING AND APPEARED TO BE UNCONSCIOUS. R/O'S OBSERVED SEVERAL CITIZENS SURROUNDING ABOVE AND ATTEMPTING TO HELP HIM OUT. R/O'S ONLY OBSERVED ONE OUT OF TWO OCCUPANTS OF UNIT 1 ON SCENE WHEN THEY ARRIVED. R/O'S UNABLE TO DETERMINE WHO WAS THE DRIVER OF UNIT 1. BT 4472 RELATED TO R/O'S THAT WHEN THEY ARRIVED ON SCENE THEY OBSERVED UNKNOWN CITIZENS PULLING OCCUPANT OF UNIT 1 OUT OF FRONT PASSENGER SIDE WINDOW. R/O'S MET WITH OCCUPANTS OF UNIT 2 WHO RELATED THEY WERE TRAVELING W/B ON CHICAGO AVE WHEN THEY WERE STRUCK BY UNIT 1 ALSO TRAVELING W/B AND ATTEMPTING TO OVERPASS THEM. AMB 15 TRANSPORTED OCCUPANT OF UNIT 1 TO STROGER, CRITICAL CONDITION PER DR SCHLANSER (INJURIES: PROFOUND BRAIN INJURY, LEFT CHEST PNEUMOTHORAX, AND SKULL FRACTURE). AMB 45 TRANSPORTED OCCUPANTS OF UNIT 2 TO WEST SUBURBAN, BOTH STABLE CONDITION PER DR NUVAL. THERE WILL BE A 10 DAY INVESTIGATION HOLD PER MAJOR ACCIDENTS FOR UNIT 1 AND UNIT 2 (UNIT 1: SSN 034629, UNIT 2: SSN 034630). SUSPECT NARCOTICS (INV#1448694, RD#JC266129) AND IL ID (INV#1448711) FOUND BY CFD TOWER#14 UNDER DRIVER'S SEAT OF UNIT#1. TWO CELLPHONES WERE FOUND ON SCENE INV#1448711 AND INV#1448705. R/O'S MADE ALL REQUIRED NOTIFICATIONS. NFI
