**NARRATIVE**

BWC REPORT. EVENT# 12044. IN SUMMARY: R/O WAS PROVIDED INITIAL INFORMATION FROM BEAT 733, OFFICER VARGAS 12368. THE WITNESS ON SCENE, [REDACTED] PROVIDED OFFICER VARGAS WITH THE DETAILS OF THE CRASH WHICH SHE OBSERVED SITTING IN HER VEHICLE FACING SOUTHBOUND ON STEWART. THE DRIVER OF UNIT 1, UNKNOWN AT THE TIME OF THIS REPORT, WAS TRAVELING EASTBOUND ON 71ST WHEN HE DISREGARDED A RED SOLID TRAFFIC SIGNAL AND MADE CONTACT WITH UNIT 2 AS SHE WAS COMPLETING HER LEFT TURN ONTO 71ST STREET. UNIT 1 THEN HIT A CURB AND TREE AND PROCEEDED TO ROLL ONTO ITS ROOF. THE VEHICLE WAS OVERTURNED WHEN R/OS ARRIVED ON SCENE. EVERY OCCUPANT FROM UNIT 1 WENT TO THE HOSPITAL. MARIO MORGAN AND DENZEL WASHINGTON WERE TRANSPORTED TO UNIVERSITY OF CHICAGO HOSPITAL BY CFD 38 AND 69, RESPECTIVELY. MR. MORGAN WAS IN FAIR CONDITION AND MR. WASHINGTON WAS IN SERIOUS CONDITION. BOTH WILL BE TREATED BY DR. [REDACTED] DONTÉ THOMAS WAS TRANSPORTED TO CHRIST HOSPITAL BY CFD 36, HE WAS IN STABLE CONDITION AND TREATED BY DR. [REDACTED] JASON YANCEY WAS PARTIALLY EJECTED OUT OF THE VEHICLE THROUGH THE WINDOW. HE WAS TRANSPORTED TO HOLY CROSS HOSPITAL BY CFD 70 AND PRONOUNCED BY DR. [REDACTED] AT 1735HRS.

THE DRIVER OF UNIT 2 ([REDACTED] [REDACTED]) RELATED THAT SHE WAS TRAVELING NORTHBOUND ON STEWART AND MADE A LEFT TURN ONTO WEST 71ST STREET WHEN UNIT 1 WAS TRAVELING AT A HIGH RATE OF SPEED, EASTBOUND, IN HER WESTBOUND LANE, HITTING HER VEHICLE ON THE FRONT RIGHT SIDE. MS. [REDACTED] RELATED THAT UNIT 1'S VEHICLE THEN FLIPPED, HITTING A TREE AND ROLLING OVER TO ITS ROOF. MS. [REDACTED] ALSO OBSERVED ONE OF THE OCCUPANTS GETTING OUT THE VEHICLE LAUGHING. MS. [REDACTED] AND HER PASSENGER [REDACTED] WERE TRANSPORTED TO ST. BERNARD HOSPITAL BY CFD 1. BOTH WERE IN STABLE CONDITION AND TREATED BY DR. [REDACTED] BEAT 712 WENT WITH CFD 1 TO ST. BERNARD. BEAT 714 WENT WITH CFD 38 TO UNIVERSITY OF CHICAGO WITH AN OCCUPANT OF THE OFFENDING VEHICLE. BEAT 724 WENT WITH CFD 69 TO UNIVERSITY OF CHICAGO WITH AN OCCUPANT OF THE OFFENDING VEHICLE. BEAT 725 WENT WITH CFD 36 WITH THE DRIVER OF THE OFFENDING VEHICLE TO CHRIST HOSPITAL. BEAT 732 WENT WITH CFD 70 TO HOLY CROSS HOSPITAL WITH AN OCCUPANT OF THE OFFENDING VEHICLE. MAJOR ACCIDENTS UNIT WAS NOTIFIED AND BEATS 5790, 5792, 5793 AND 5798 ALL ARRIVED ON SCENE TO INVESTIGATE THE FATAL CRASH. EVIDENCE TECHNICIAN BEAT 5822 DALY #18890 WAS NOTIFIED AND ARRIVED ON SCENE AT 1825HRS. ET DALY #18890 RECOVERED 2 WEAPONS ON SCENE. MEDICAL EXAMINER SANTORO #75 WAS ON SCENE AND PROVIDED AN ME CASE NUMBER OF: 2019-03187. COPA INVESTIGATORS AND STREET DEPUTY VALADEZ #4B ARRIVED ON SCENE TO CONDUCT THEIR INVESTIGATION.
