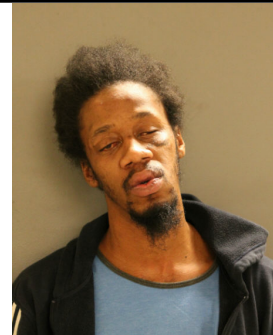

ARREST REPORTING

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

INCIDENT NARRATIVE

Event#08288 IR#1781566. The following is an arrest by beat 6728B. Arresting Officers (A/O)s were on patrol, when they both observed the above arrestee now known as KERSH, Bernard M/1/29 standing inside the CTA Bus Shelter drinking from a 750ML glass bottle labeled New Amsterdam flavored Vodka. A/Os exited their vehicles to conduct an investigatory stop. Above arrestee became irate and began to direct profanities at A/Os. A/Os, for the purpose of issuing an Administrative Notice of Ordinance Violation (ANOV) requested the arrestee provide his identification. A/Os had not identified arrestee and were unable to issue a citation. Believing that this offense will continue, Officer Williams positioned himself behind arrestee and informed arrestee that he would be placed into custody. Officer Kerr, while seated inside of his patrol vehicle and utilizing the CLEAR system, attempted to ascertain the identity of the above male arrestee. The above arrestee licked Officer Williams's cheek by sliding his tongue across Officer Williams's cheek. Officer Williams attempted to place arrestee into custody by attempting to apply a wrist lock and escort hold of the arrestee. Arrestee continued to stiffen his arm and pull away in an attempt to defeat arrest becoming an active resistor. Arrestee stated not verbatim, "man take that fucking badge off and I'll fuck your ass up,"; while stiffening and clenching his fists. P.O. Williams in fear of receiving a battery, attempted another wrist lock with no success. Arrestee then turned and spat in Officer Williams's face becoming an assailant, delivering arrestee's saliva inside of Officer Williams's eyes and mouth. P.O. Williams, attempted another wristlock and arrestee's arms and wrist stiffened once again. With the arrestees's spit lodged inside Officer Williams's eyes and unable to see clearly, P.O. Williams immediately conducted an emergency take down to place arrestee into custody and prevent any additional injuries to himself. During the emergency take down, arrestees's head struck sidewalk. A/Os immediately requested EMS and directed additional units to the scene for assistance. Shortly thereafter, EMS ambulance#24 arrived on scene. Beat 631 (P.O. Johnson#8781 / P.O. Mason#15802) responded and transported arrestee to University of Chicago hospital. Beat 610, Sgt. Price#2257 also responded and was on scene. Arrestee transported to the University of Chicago for medical treatment. He was treated and released by Dr. [REDACTED] CATSCAN NEGATIVE. P.O. Williams was also transported to the University of Chicago. Name check of arrestee was clear of any wants, warrants and investigative alerts. Not on parole or probation. Evidence Technician CERVENKA#8218 was requested to photograph both P.O. Williams and Arrestee. Area South Detectives Smith#20836 and Burg#20100 (Beat#5237) notified. Gang Affiliation: Gangster Disciple.
