 EVENT#14716, BWC RECORDED AND REVIEWED. UNMARKED POLICE VEHICLE/CIVILIAN DRESS. IN SUMMARY, A/O'S WERE GOING TO ASSIST BEAT 1163D ON A TRAFFIC STOP ON THE 3900 BLOCK OF W. WILCOX AND OBSERVED THE ABOVE OFFENDER WALKING AWAY FROM THE DIRECTION OF 1163D TRAFFIC STOP IN A HURRIED MANNER. A/O'S FURTHER OBSERVED THE OFFENDER CROSS THE STREET FROM THE SOUTH SIDE OF WILCOX TO THE NORTH SIDE OF WILCOX WHERE A CROSS WALK WAS NOT PROVIDED AND OBSERVED THE OFFENDER ADJUST HIS WAISTBAND IN A MANNER CONSISTENT WITH A/O'S TRAINING AND EXPERIENCE AS THAT OF AN ARMED SUBJECT. A/O'S ATTEMPTED TO CONDUCT A FIELD INTERVIEW OF THE OFFENDER AT WHICH POINT THE OFFENDER LOOKED IN A/O'S DIRECTION AND FLED ON FOOT. DURING THE FOOT PURSUIT, THE OFFENDER PRODUCED A BLACK HANDGUN AND POINTED SAID BLACK HANDGUN IN THE DIRECTION OF A/O SWEEZER, PLACING HIM AN IMMIMENT FEAR OF DEATH OR GREAT BODILY HARM. IN DEFENSE OF HIS SELF, A/O SWEEZER DISCHARGED HIS DUTY WEAPON STRIKING THE OFFENDER. THE OFFENDER CONTINUED TO FLEE TO THE FRONT OF 3924 W. WILCOX WHERE THE OFFENDER WAS PLACED INTO CUSTODY. A SEMI-AUTOMATIC HANDGUN WAS RECOVERED AT THE SCENE. THE OFFENDER WAS TRANSPORTED TO MT SINAI HOSPITAL BY CFD AMB 23. OFFENDER DOES NOT POSSESS A VALID FOID/CCL. NAME CHECK CLEAR. ISR COMPLETED.
