NARRATIVE

IN SUMMARY, R/O WAS WAIVED DOWN BY CONCERNED MOTORIST THAT THERE WAS A FIGHT BY THE BOWLING ALLEY. R/O RELOCATED TO THE SAID LOCATION AND OBSERVED 2 OFF DUTY CHICAGO POLICE OFFICERS STRUGGLING WITH A MALE BLACK AS THEY ATTEMPTED TO PLACE OFFENDER UNDER ARREST. R/O ASSISTED THE 2 OFF DUTY POLICE OFFICERS AND HANDED THEM A PAIR OF HANDCUFFS AS PO COLLAZO HANDCUFFED THE OFFENDER. R/O LEARNED FROM THE OFF DUTY POLICE OFFICERS THAT THEY ON VIEWED A DOMESTIC BATTERY. THEY RELATED THAT THEY OBSERVED ABOVE OFFENDER WITH A CLOSED FIST PUNCH THE VICTIM TO THE LEFT SIDE OF THE HEAD AND ANOTHER PUNCH TO THE BODY. OFFENDER THEN BODY HUGGED THE VICTIM AND LIFTED HER OFF THE GROUND AND STARTED TO CARRY VICTIM AWAY. THE 2 POLICE OFFICERS GAVE NUMEROUS VERBAL DIRECTIONS FOR OFFENDER TO STOP AND TO LET VICTIM GO AS THEY ANNOUNCED THEIR OFFICE. PO'S WALKED TOWARDS OFFENDER AND P/O DALCASON GRABBED OFFENDERS LEFT SHOULDER IN ORDER TO SEPARATE VICTIM AND OFFENDER. OFFENDER PUSHED PO.DALCASON AWAY AND A PHYSICAL ALTERCATION ENSUED. OFFENDER PUNCHED PO.DALCASON AND PUNCHES WERE EXCHANGED AS BOTH FELL TO THE GROUND. P/O CALDASON TRIED PLACE OFFENDER UNDER ARREST AND VICTIM INTERFERED AS SHE TRIED TO GET BETWEEN OFFENDER AND P/O. PO.COLLAZO PULLED VICTIM AWAY FROM OFFENDER AND OFFENDER WAS PLACED UNDER ARREST. BEAT 1921 CALLED FOR AN ASSIST AND EMS WAS REQUESTED FOR MEDICAL ATTENTION FOR LACERATIONS ON OFFENDER'S EYE BROW. BOTH OFFENDER AND VICTIM ARE HIGHLY INTOXICATED. VICTIM VERY UNCOOPERATIVE AND WOULD NOT GIVE ANY INFORMATION. VICTIM WOULD NOT ACCEPT VICTIM INFORMATION NOTICE.
