EVENT #01012 BWC AND ICC RECORDED. IN SUMMARY R/O'S WERE ASSISTING BEAT 413R TO A DISPATCHED CALL OF A BATTERY IN PROGRESS AT THE ABOVE LOCATION. BEAT 413R RELATED THAT THEY WITNESSED DARRYL WRIGHT(OFFENDER/DRIVER/ACQUAINTANCE OF VICTIM) DRIVING THE ABOVE LISTED VEHICLE MATCHING THE DESCRIPTION GIVEN BY OEMC FROM THE LOCATION NORTHBOUND ON STONY ISLAND. BEAT 413R RELATED THEY ACTIVATED EMERGENCY LIGHTS IN AN ATTEMPT TO CURB THE VEHICLE. AT THIS TIME R/O'S OBSERVED [REDACTED] (VICTIM/PASSENGER/ACQUAINTANCE OF OFFENDER) WAVING HER HANDS FRANTICALLY OUT OF THE PASSENGER SIDE WINDOW IN AN ATTEMPT TO GET R/O'S ATTENTION. AS THE OFFENDER CONTINUED DRIVING R/O'S OBSERVED [REDACTED] (VICTIM) ATTEMPT TO OPEN THE PASSENGER DOOR AND JUMP FROM THE MOVING VEHICLE TO FLEE FROM THE OFFENDER. R/O'S OBSERVED THE VICTIM OPEN THE DOOR THREE SEPARATE TIMES TO MAKE AN ESCAPE. AT THIS TIME OFFENDER INCREASED SPEED OF THE VEHICLE WHILE NOW TRAVELING EASTBOUND ON 91ST. DARRYL WRIGHT(OFFENDER) DISREGARDED MULTIPLE STOP SIGNS WHILE TRAVELING EASTBOUND AT A HIGH RATE OF SPEED WITH BEAT 413R PURSUING.(PURSUIT #19-0259). BEAT 413R OBSERVED THE OFFENDING VEHICLE DISREGARD THE SOLID RED STOPLIGHT AT THE INTERSECTION OF 91ST AND JEFFERY. AS R/O'S APPROACHED SAME SAID INTERSECTION R/O'S SLOWED SQUAD CAR FOR SAFETY MEASURES AND LOST SIGHT OF THE OFFENDING VEHICLE. R/O'S CONTINUED TO TRAVEL EASTBOUND ON 91ST STREET TO TOUR THE AREA AND OBSERVED THE TRAFFIC CRASH RECORDED UNDER RD#JC558453. AMBULANCE 22 TOOK VICTIM TO U OF C HOSPITAL UNDER THE CARE OF DR. [REDACTED] IN STABLE CONDITION. AMBULANCE 22 TOOK OFFENDER TO U OF C

HOSPITAL WHERE HE WAS PRONOUNCED BY DR. [REDACTED] AT 0230HRS. VICTIM WAS INTERVIEWED ON SCENE AND RECORDED BY BWC STATING (NOT VERBATIM) I WAS IN FEAR FOR MY LIFE, HE(OFFENDER) THREATENED TO KILL ME AND MY CHILDREN, AND THAT SHE(VICTIM) WAS ATTEMPTING TO GAIN THE ATTENTION OF THE POLICE BY WAVING HER HANDS OUT THE WINDOW OF THE VEHICLE. BEAT 412R ACCOMPANIED VICTIM TO THE HOSPITAL AND DURING BWC RECORDED INTERVIEW VICTIM AGAIN RELATED TO R/O'S THE THREATS AND FEAR FOR HER LIFE CAUSED BY THE OFFENDER.
