

SUMMARY REPORT OF INVESTIGATION¹

I. EXECUTIVE SUMMARY

On September 4, 2013, several officers responded to a OEMC call of a man with a gun. Upon the officers arriving, they saw [REDACTED] and he fled from the officers. The officers pursued [REDACTED] fled through the house, down a gangway and through the alley. While in the gangway, Officer [REDACTED] knocked a weapon out of [REDACTED] hand. [REDACTED] continued to run, and officers continued to pursue him. [REDACTED] ran to a gas station and at that point officers were able to catch up with [REDACTED]. According to [REDACTED] he surrendered when he reached the gas station, but officers stated that [REDACTED] kept resisting and they had to use open hand/close hand strikes to get [REDACTED] to comply as well as an emergency takedown. [REDACTED] was subsequently placed into custody and transported to the [REDACTED] district for processing.

Federal Laws

The Fourth Amendment to the United States Constitution provides in relevant: “[t]he right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated” U.S. CONST. amend IV. Determinations regarding the potential use of excessive force in the course of an arrest, investigatory stop, or other seizure are properly analyzed under the Fourth Amendment’s objective reasonableness standard.

V. INVESTIGATION³

a. Interviews

Civilian Interview

█████ was interviewed on February 11, 2016 over the telephone while he was housed at Pinckneyville Correctional Center. On September 4, 2013, he was sitting on the porch at █████ with a friend when five police vehicles pulled up. According to █████ his friend’s girlfriend resides at that address. The officers got out of the first vehicle with their weapons drawn and pointed at █████ The officers ordered █████ to come to the vehicle, but █████ ignored the orders and started running because he was scared. The officers pursued █████ ran inside the building that he was sitting in front of and ran out the back door. █████ continued to run through alleys until he made in to Halsted Street. █████ heard the officers ordering him to stop running, but █████ ignored the commands because he was scared. Once █████ reached Halsted Street, he stopped inside a gas station parking lot. █████ stopped running and put his hands up in the air and surrendered. █████ is unsure whether it was a Marathon or Mobile gas station, but the address of the gas station is 6659 S. Halsted Street.

One of the officers that was chasing █████ ran up to him and threw him to the ground and started to punch and kick █████ Other officers joined, about four or five, in kicking and punching

Officers punched him in the ribs, face and in his forehead. According to the officers kept saying don't resist, but he was not moving. stated that he balled up on the ground and tried to block some of the punches, but he could not because the officers were holding his arms. stopped moving and his body went limp, but the officers just kept beating him. The officers beat for two to three minutes. After the officers finished kicking and punching him, the officers placed into handcuffs and took him to the station on 63rd Street and Loomis Street. According to there were five officers who were kicking and punching him. also stated that the cell the officers placed him in was covered with feces.

According to when he was arrested, he did not have a handgun on him, but there was a handgun on the porch next to where he was sitting. stated that the handgun but belonged to somebody in the neighborhood. admitted to touching/holding the gun earlier in the day before the police arrived.⁴

was deposed by video on April 6, 2016. According to on the date of the incident, he was on the porch at Street talking to his three friends. One of his friends had a gun. described the gun as a 38 and that it was black or blue. looked at the gun and held it in his hand. gave the gun back to his friend before the police arrived. About 20 to 25 minutes had passed between handing the gun back to his friend and the police arriving. According to his friend had placed the gun under the porch.

Five police vehicle arrived, and three to four officers got out of the vehicles and ran up to with their weapons drawn. When observed the officers running toward him, he ran. ran through the first floor and into the backyard, then into the alley. According to he did not have a weapon on him when he was running. ran through the alley toward the gas station. heard the officers say freeze and stop, but he continued to run because he was in a gangway and he wanted to get to an area where there was a camera or people present. stated that the police had just killed somebody in the same area just a few weeks before this incident, so he was scared to stop in the gangway.

continued to run until he reached the gas station. According to once he reached the gas station he surrendered because he was in front of cameras. The officers grabbed threw him to the ground and started stomping and beating him. One of the officers broke his fist on forehead. According to it was five to six officers who were beating him. mentioned Officers and by name and stated that there was a black officer who assisted in the beating. was hit more than five times in the head with closed fists. also stated that he was kicked about five to six times. was kicked in his ribs, back and legs. stated that the officers told him to stop resisting, but he was not resisting. stated that he was out of breath from running four blocks, so he was not resisting. According to the officers kept beating him until he screamed. estimated that the officers beat him for a minute and a half to two minutes. was then transported the district.

According to [REDACTED] when he was being processed at the district he asked for medical attention twice and never received it. [REDACTED] stated he was also placed in a holding cell with feces and pee everywhere.⁵

[REDACTED] brother, was deposed on December 28, 2016. [REDACTED] was incarcerated during the time of the incident but stated that he was on the phone with another one of his brothers, [REDACTED] who was present during the incident.⁶

Officers Interviews

Officer [REDACTED] was interviewed on September 16, 2016 at the IPRA offices. According to Officer [REDACTED] on the date of the incident he was partnered with Officer [REDACTED]. On the date of the incident, Officer [REDACTED] was responding to an OEMC call of a person with a gun. Upon arrival Officer [REDACTED] observed [REDACTED] fleeing into a residence. Officer [REDACTED] paralleled [REDACTED] by running through the alley. As Officer [REDACTED] reached the alley, he observed [REDACTED] fleeing through the rear of the residence into the alley armed with a handgun.

Officer [REDACTED] pursued [REDACTED] along with Officer [REDACTED]. During the foot chase Officer [REDACTED] knocked the handgun out of [REDACTED] hand. [REDACTED] continued to flee, and Officer [REDACTED] continued to pursue him. [REDACTED] fled eastbound onto 67th Street until he reached Halsted street. When [REDACTED] reached Halsted Street he went into the gas station lot at 6659 S. Halsted. As [REDACTED] entered the gas station lot, Officer [REDACTED] caught up with [REDACTED] and he tried to place [REDACTED] into custody. [REDACTED] continued to resist by trying to flee and pull away, at which point Officer [REDACTED] performed an emergency takedown. When [REDACTED] was on the ground, he continued to resist by pulling away, swung his arms and attempted to get up. Officer [REDACTED] used open hand strikes and closed hand strikes to get [REDACTED] to comply with his verbal instructions and stop resisting. Eventually other officer arrived and assisted with putting [REDACTED] into handcuffs.

Officer [REDACTED] and Officer [REDACTED] transported [REDACTED] to the [REDACTED] District. According to Officer [REDACTED] he asked [REDACTED] if he needed medical attention, to which [REDACTED] replied no. A more thorough search was performed of [REDACTED] and then he was placed in an interview room. Officer [REDACTED] denied kicking [REDACTED] and he also denied placing [REDACTED] in an unsanitary cell. Officer [REDACTED] right hand was fractured as a result of the incident.⁷

Officer [REDACTED] was deposed on October 13, 2016. Officer [REDACTED] testimony was consistent with the statement he provided to IPRA. Officer [REDACTED] added during the deposition that he announced his officer and shouted for [REDACTED] to stop and drop the gun.⁸

Officer [REDACTED] was interviewed on September 8, 2016 at IPRA offices. On the date of the incident, Officer [REDACTED] was working with his partner Officer [REDACTED] in uniform in a marked vehicle. According to Officer [REDACTED] he responded to person with a gun call. When Officer [REDACTED] arrived, [REDACTED] had already fled on foot from his initial position. According to Officer [REDACTED] fled into

the alley. While in the alley, Officer ██████ knocked a weapon out of ██████ hand. Officer ██████ never saw ██████ with a weapon, but he observed the weapon at the station.

Officer ██████ and his partner briefly separated while they were searching for ██████. Officer ██████ observed ██████ again at a gas station. At that time, Officer ██████ observed his partner struggling with ██████ trying to take ██████ to the ground. ██████ was trying to pull away, he was moving and resisting. Officer ██████ assisted and did a takedown of ██████ he grabbed ██████ upper body and performed a swing kick to one of his legs and took ██████ to the ground. Officer ██████ managed to get control of one of ██████ arms and another officer got control of ██████ other arm. ██████ was then placed into custody. Once ██████ was in custody, Officer ██████ searched him for other weapons and then transported him to the district. Once at the district, ██████ was placed in the bullpen. Officer ██████ denied kicking ██████ in the face, in the head and in the stomach. Officer ██████ also denied ever punching ██████ and ever placing his knee on ██████ neck.⁹

Officer ██████ was deposed on October 13, 2016. Officer ██████ testimony was consistent with the statement he provided to IPRA.¹⁰

Officer ██████ was interviewed on September 8, 2016 at IPRA offices. Officer ██████ was a probationary police officer at the time of the incident. On the date on the incident, Officer ██████ was in uniform in a marked police van with several other officers. According to Officer ██████ he responded to a call with a male with a gun. As Officer ██████ was watching the alley he observed ██████ fleeing from the rear of the house. Officer ██████ began chasing ██████. As they were running toward a gangway, Officer ██████ noticed a weapon in ██████ left hand. Officer ██████ lunged at ██████ and knocked the weapon out of ██████ hand. ██████ continued to flee, and Officer ██████ picked up the weapon and placed it in his pocket. Officer ██████ continued to pursue ██████. Officer ██████ continued to pursue ██████ for another 30 seconds until ██████ ran into Officers ██████ and ██████ at a gas station. ██████ was placed into custody by several other officers, Officer ██████ did not assist in placing ██████ into custody. Officer ██████ also denied placing ██████ into an unsanitary cell.¹¹

Officer ██████ was interviewed on September 19, 2018 at IPRA offices. According to Officer ██████ on the date of the incident he was in uniform and in a marked vehicle. Officer ██████ received a radio transmission of a male with a gun. Officer ██████ relocated to the address given in the transmission and observed ██████ sitting on the front porch. As Officer ██████ approached ██████ he stood up, grabbed his waistband and ran into the house. Officer ██████ went around the side of the house and called for additional units. As Officer ██████ reached the back of the house, ██████ had already exited the back of the house and Officer ██████ lost sight of him. By the time Officer ██████ observed ██████ again, he was already placed into custody. Officer ██████ did not transport ██████ so he did not place ██████ into a cell. Officer ██████ also never heard ██████ asking for medical attention.¹²

Officer [REDACTED] was deposed on November 18, 2016. Officer [REDACTED] testimony was consistent with the statement he provided to IPRA.¹³

Sergeant [REDACTED] was interviewed on September 20, 2016 at IPRA offices. On September 4, 2013, Sergeant [REDACTED] responded to a call for assistance over the radio. The call was in reference to officers chasing somebody, possibly with a weapon. Sergeant [REDACTED] responded to area and went to a house on the 6600 block of Union Street. As Sergeant [REDACTED] reached the front porch, he heard a call over the radio stating that the offender was in custody. Sergeant [REDACTED] never saw the offender and never approved any paperwork dealing with the offender.¹⁴

Sergeant [REDACTED] was interviewed on October 6, 2016 at IPRA offices. On the date¹⁵ of the incident, Sergeant [REDACTED] responded to a man with a gun call. Upon arriving at the scene, Sergeant [REDACTED] observed a man sitting on the porch and then the man got up and ran into the house. Sergeant [REDACTED] immediately went around to the back, by the time he reached the back the man was running through the alley. Sergeant [REDACTED] went around onto Marquette and stopped the car and jumped out. Other officers were also there trying to stop [REDACTED] but [REDACTED] turned around and ran to a gas station. Sergeant [REDACTED] proceeded to the gas station. [REDACTED] was placed under arrest at the gas station. According to Sergeant [REDACTED] [REDACTED] was struggling a little bit. Sergeant [REDACTED] did not see any officers kick and punch [REDACTED] he did not see any officers beating [REDACTED]¹⁶

Sergeant [REDACTED] was interviewed on September 7, 2016 at IPRA offices. On the date of the incident, Sergeant [REDACTED] responded to a call of a person with a gun near the 6600 block of Union. When Sergeant [REDACTED] arrived, she observed officers running through the building in pursuit of the offender and she joined in the pursuit. When she caught up with Officer [REDACTED] she stopped because Officer [REDACTED] had picked up the weapon. Sergeant [REDACTED] stayed on Union with Officer [REDACTED] to make sure that he was okay. Sergeant [REDACTED] did not witness the apprehension of [REDACTED] and did not see [REDACTED] after he was apprehended.¹⁷

Officer [REDACTED] was interviewed on November 18, 2016 at IPRA offices. Officer [REDACTED] was assigned to the [REDACTED] district male lock-up on September 4, 2013. Officer [REDACTED] has no recollection of [REDACTED] but stated that at no time would a prisoner be placed in an unsanitary cell. Officer [REDACTED] also stated that it is not the responsibility of the lock-up personnel to maintain the clean-up. If a cell was deemed uninhabitable, the prisoner would be removed from the cell and the cell would not be used until it has been cleaned. The lock-up personnel also conduct fifteen-minute visual cell checks to ensure the safety of the prisoner.¹⁸

Detention Aide [REDACTED] was interviewed on November 17, 2016 at IPRA offices. [REDACTED] was assigned to the [REDACTED] district male lock-up on September 4¹⁹, 2013. [REDACTED] has no recollection of [REDACTED] but stated that at no time would a prisoner be placed in an unsanitary cell. The cells in the

lock-up area are cleaned daily and during each watch. If a cell was deemed uninhabitable, the prisoner would be removed from the cell and the cell would not be used until it has been cleaned. The lock-up personnel also conduct fifteen-minute visual cell checks to ensure the safety of the prisoner. According to ██████ the city has a contract with a cleaning company to service the police districts and that he does not clean the cells.²⁰

Detention Aide ██████ was interviewed on November 18, 2016 at IPRA offices. ██████ was assigned to the ██████ district male lock-up on September 4, 2013. ██████ has no recollection of ██████ but stated that at no time would a prisoner be placed in an unsanitary cell. The cells in the lock-up area are cleaned daily and during each watch. If a cell was deemed uninhabitable, the prisoner would be removed from the cell and the cell would not be used until it has been cleaned. The lock-up personnel also conduct fifteen-minute visual cell checks to ensure the safety of the prisoner. According to ██████ the city has a contract with a cleaning company to service the police districts and that the he does not clean the cells.²¹

Officer ██████ was deposed on October 13, 2016. On the date of the incident, ██████ was partnered with Officer ██████. Just prior to responding to the incident address on Union Street, Officer ██████ and his partner had responded to a person with a gun call a couple blocks east of Union Street. When Officer ██████ was on Lowe Street, a call came over the radio of a person with a gun on Union. Officer ██████ and his partner responded to the call on Union Street. There were four people on the porch, one of the people²² on the porch matched the description given of the person with a gun. Officer ██████ asked ██████ to stand up and walk toward him. ██████ stood up and grabbed his waistband and turned around and ran into the building. Officer ██████ did not see ██████ with a gun but he believed ██████ had a gun because he matched the description given and he fled while holding his waistband.

Officer ██████ attempted to follow ██████ but the gate was locked. Officer ██████ got on the radio and asked for a car to go to the rear of the building. Officer ██████ asked the individuals on the porch to unlock the gate and they complied. Officer ██████ entered the building and went up to the second floor. Officer ██████ asked the woman in the apartment if somebody dropped anything. While Officer ██████ was in the apartment, he heard over the radio that ██████ had been apprehended and a handgun recovered.²³

Detective ██████ was deposed on November 18, 2016. Detective ██████ was not present for the arrest of ██████ but he did speak/interview ██████ in regards to the incident and he recorded that interview in his general progress report.²⁴

Detective ██████ was deposed on November 18, 2016. Detective ██████ was not present for ██████ arrest. Detective ██████ assisted Detective ██████ with his interview of ██████ at the ██████ district police station.²⁵

b. Documentary Evidence

The **original case incident report and arrest report** document officers responded to a call of a person with a gun at [REDACTED]. Upon arrival, arresting officers observed [REDACTED] sitting on the front steps of the porch matching the description of the man with a gun. Officers approached for a field interview, and [REDACTED] got up and ran up to the second floor. Arresting officers called for assistance and responding officers observed [REDACTED] running out of the rear of the building. Officer [REDACTED] observed [REDACTED] run into an alley with a handgun in his left hand. Officer [REDACTED] knocked the handgun loose from [REDACTED] hand and recovered a blue steel .38 revolver at 720 W. Marquette Rd. [REDACTED] continued flee westbound where he was placed into custody by beat [REDACTED] at 6659 S. Halsted Street.²⁶

The **case supplementary report** document that [REDACTED] spoke with detectives. According to the report, [REDACTED] related that he saw the cops and got up and ran in the house. [REDACTED] stated he purchased the gun for \$200 and he did not know the serial numbers were taken off. [REDACTED] stated he did not see the police in the alley during the chase and that the gun came out of his hand, he further related that he stopped for the police.²⁷

A **Tactical Response Report (TRR)** completed by Officer [REDACTED] document [REDACTED] did not follow verbal direction, stiffened, fled, pulled away and flailed his arms. [REDACTED] was classified as a passive resister, active resister and an assailant. Member's response is listed as member presence, verbal commands, open hand strike, close hand strike/punch and emergency handcuffing and take down.²⁸

A **Tactical Response Report (TRR)** completed by Officer [REDACTED] document [REDACTED] did not follow verbal direction, stiffened, fled, pulled away and flailed his arms. [REDACTED] is classified as a passive resister, active resister and an assailant. Member's response is listed as member presence, verbal commands, kicks and emergency handcuffing and take down.²⁹

c. Additional Evidence

[REDACTED] filed a civil suit ([REDACTED]) in which he alleges he was beaten by several officers and that supervisors were present on scene and failed to intervene/order the officers to stop. Further he alleged he was denied medical attention and placed in an unsanitary cell. The lawsuit was settled before trial for \$4,000.³⁰

V. ANALYSIS

Officer [REDACTED] Allegations

1. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you kicked [REDACTED] about the face, body, head, stomach and legs;

COPA finds this allegation not sustained. According to G03-02-02, a resister is a person who is uncooperative. Resisters are further subdivided into two categories, passive and active. A passive resister is defined as a person who fails to comply with verbal or other direction. An active resister is defined as a person whose actions attempt to create distance between that person and the member's reach with the intent to avoid physical control and or defeat the arrest. Holding techniques can be used on a passive resister and it can be escalated to striking or slapping to disorient the subject. An assailant is defined as a subject who is using or threatening the imminent use of force against himself or another person. Assailants are categorized into three categories. The first category includes actions that are aggressively offensive without weapons. The second category includes actions likely to cause physical injury. The third category is actions likely to cause death or serious physical injury. When a subject is classified as an assailant, direct mechanical techniques such as punching and kicking and powerful locks. These techniques can be combined with take-downs or pins against the ground or other objects.

According to [REDACTED] on the date of the incident, several officers got out of their vehicle with their weapons drawn and pointed at [REDACTED] was scared so he ran. The officers ordered [REDACTED] to stop, but he ignored their orders. [REDACTED] ran to a gas station and that is where several officers beat and kicked him. By [REDACTED] own admission he was both an active and passive resister. According to Officer [REDACTED] ran from the officers and continued to resist even when officers tried to place him under arrest at the gas station. Officer [REDACTED] documents on his TRR that he used open hand strikes and closed hand strikes to get [REDACTED] to comply, which under the general order are acceptable techniques. Officer [REDACTED] denied kicking [REDACTED] There is no independent evidence to support [REDACTED] assertions that Officer [REDACTED] kicked him, neither is there independent evidence to support Officer [REDACTED] assertions that he did not kick [REDACTED] as such, COPA finds this allegation not sustained.

2. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you punched [REDACTED] about the body, head, and legs;

COPA finds this allegation not sustained. Officer [REDACTED] documents on his TRR that he used open hand strikes and closed hand strikes to get [REDACTED] to comply because he was resisting. According to Officer [REDACTED] was flailing and swinging his arms when he was trying to arrest [REDACTED] at the gas station. While punching and slapping is a technique that can be used when a subject is classified as an assailant. The members punching, and slapping cannot be excessive and must be the appropriate level of force used based on the subject's actions. COPA finds that there is no independent evidence to support [REDACTED] assertions that the strikes used were excessive. [REDACTED] admits to resisting at first, but then states that he finally complied at the gas station. However,

Officer ██████ assertion is that ██████ did not comply and that is why he used hand strikes to get him to comply. There is also no independent evidence to support that Officer ██████ strikes were not excessive and therefore, COPA finds the allegation not sustained.

3. It is reported in civil suit# ██████ filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you punched ██████ on the face;

COPA finds this allegation not sustained. Officer ██████ documents on his TRR that he used open hand strikes and closed hand strikes to get ██████ to comply. ██████ admits to resisting at first, but then states that he finally complied at the gas station. However, Officer ██████ assertion is that ██████ did not comply and that is why he used hand strikes to get him to comply. There is no independent evidence to support that Officer ██████ strikes were excessive, nor is there independent evidence to support that his strikes were not excessive. Further, there is no evidence to prove or disprove that the strikes landed in ██████ face; and therefore, COPA finds the allegation not sustained.

4. It is reported in civil suit# ██████ filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you placed a knee onto ██████ neck;

COPA finds this allegation not sustained. According to Officer ██████ he only used open hand and closed hand strikes to get ██████ to comply. While ██████ asserts that officers beat him, there is no independent evidence to support this assertion, as such, COPA finds the allegation not sustained.

5. It is further alleged that while at the ██████ district station, Officer ██████ denied ██████ medical attention.

COPA finds this allegation not sustained. According to Officer ██████ he asked ██████ if he needed medical attention and ██████ declined medication attention. ██████ stated that he asked twice for medical attention, but he does not state that he asked Officer ██████ for medical attention. With no independent evidence to support ██████ assertion, COPA finds the allegation not sustained.

6. It is further alleged that while at ██████ District Station you placed him in an unsanitary cell with smeared feces and urine on the walls.

COPA finds this allegation not sustained. ██████ states that on the night he was arrested, he was taken back to the district and placed in an unsanitary cell. Officer ██████ denied placing ██████ in an unsanitary cell. Officer ██████ was present the day of ██████ arrest, but he does not recall ██████ he also stated that at no time would a prisoner be placed in an unsanitary cell. Detention Aide ██████ and Detention Aide ██████ were also present the day ██████ was arrested, but they do not recall ██████ and ██████ also stated that a prisoner would not be placed in an unsanitary cell. There is no independent evidence to support ██████ or Officer ██████ assertions, so COPA finds this allegation not sustained.

Officer [REDACTED] Allegations

1. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you kicked [REDACTED] about the face, body, head, stomach and legs;

COPA finds this allegation not sustained. According to G03-02-02, a resister is a person who is uncooperative. Resisters are further subdivided into two categories, passive and active. A passive resister is defined as a person who fails to comply with verbal or other direction. An active resister is defined as a person whose actions attempt to create distance between that person and the member's reach with the intent to avoid physical control and or defeat the arrest. Holding techniques can be used on a passive resister and it can be escalated to striking or slapping to disorient the subject. An assailant is defined as a subject who is using or threatening the imminent use of force against himself or another person. Assailants are categorized into three categories. The first category includes actions that are aggressively offensive without weapons. The second category includes actions likely to cause physical injury. The third category is actions likely to cause death or serious physical injury. When a subject is classified as an assailant, direct mechanical techniques such as punching and kicking and powerful locks. These techniques can be combined with take-downs or pins against the ground or other objects.

According to [REDACTED] on the date of the incident, several officers got out of their vehicle with their weapons drawn and pointed at [REDACTED] was scared so he ran. The officers ordered [REDACTED] to stop, but he ignored their orders. [REDACTED] ran to a gas station and that is where several officers beat and kicked him. By [REDACTED] own admission he was both an active and passive resister. According to Officer [REDACTED] ran from the officers and continued to resist even when officers tried to place him under arrest at the gas station. Officer [REDACTED] documents in his TRR that [REDACTED] was not complying and that he used a kick and an emergency takedown to get [REDACTED] to comply. These techniques are acceptable under the general order when dealing with a person who is resisting. Officer [REDACTED] denied kicking [REDACTED] in the face, in the head, and in the stomach. While Officer [REDACTED] does admit to doing a swing kick to get [REDACTED] to comply, there is no independent evidence to prove or disprove that the kick was excessive. As such, COPA finds the allegation not sustained.

2. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you punched [REDACTED] about the body, head, and legs;

COPA finds this allegation not sustained. [REDACTED] alleges that multiple officers beat him, but he does not identify Officer [REDACTED] by name. Officer [REDACTED] denied ever punching [REDACTED] There is no independent evidence to support [REDACTED] assertions, neither is there independent evidence to support Officer [REDACTED] assertion that he did not punch [REDACTED] As such, this allegation is not sustained.

3. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you punched [REDACTED] on the face;

COPA finds this allegation not sustained. [REDACTED] alleges that multiple officers beat him, but he does not identify Officer [REDACTED] by name. Officer [REDACTED] denied ever punching [REDACTED]. There is no independent evidence to support [REDACTED] assertions, neither is there independent evidence to support Officer [REDACTED] assertion that he did not punch [REDACTED]. As such, this allegation is not sustained.

4. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you placed a knee onto [REDACTED] neck;

COPA finds this allegation not sustained. According to Officer [REDACTED] he only used a swing kick and an emergency takedown to get [REDACTED] to comply. Officer [REDACTED] also denied placing a knee in [REDACTED] neck. While [REDACTED] asserts that officers beat him, there is no independent evidence to support this assertion, as such, COPA finds the allegation not sustained.

5. It is further alleged that while at the [REDACTED] district station, Officer [REDACTED] denied [REDACTED] medical attention.

COPA finds this allegation not sustained. While [REDACTED] states that he requested medical attention twice, he does not state that he asked Office [REDACTED] specifically. With no independent evidence to support [REDACTED] assertion, COPA finds the allegation not sustained.

6. It is further alleged that while at [REDACTED] District Station you placed him in an unsanitary cell with smeared feces and urine on the walls.

COPA finds this allegation not sustained. [REDACTED] states that on the night he was arrested, he was taken back to the district and placed in an unsanitary cell. According to Officer [REDACTED] he only assisted with placing [REDACTED] into the bullpen. Officer [REDACTED] was present the day of [REDACTED] arrest, but he does not recall [REDACTED]. [REDACTED] he also stated that at no time would a prisoner be placed in an unsanitary cell. Detention Aide [REDACTED] and Detention Aide [REDACTED] were also present the day [REDACTED] was arrested, but they do not recall [REDACTED] and [REDACTED] also stated that a prisoner would not be placed in an unsanitary cell. There is no independent evidence to support [REDACTED] assertion, so COPA finds the allegation not sustained.

Officer [REDACTED] Allegations

1. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you kicked [REDACTED] about the face, body, head, stomach and legs;

COPA finds this allegation not sustained. According to [REDACTED] on the date of the incident, several officers got out of their vehicle with their weapons drawn and pointed at [REDACTED] was scared so he ran. The officers ordered [REDACTED] to stop, but he ignored their orders. [REDACTED] ran to a gas station and that is where several officers beat and kicked him. According to Officer [REDACTED] he assisted with the pursuit of [REDACTED] but did not assist with placing [REDACTED] into custody. Officer [REDACTED] pursued [REDACTED] until he ran into Officers [REDACTED] and [REDACTED] at the gas station. There is no independent evidence to support Officer [REDACTED] assertion that he did not assist with [REDACTED] placement into custody, nor is there independent evidence to support [REDACTED] assertion that he was beat by Officer [REDACTED] as such, COPA finds this allegation not sustained.

2. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you punched [REDACTED] about the body, head, and legs;

COPA finds this allegation not sustained. According to [REDACTED] officer punched him and beat him when he was at the gas station. Officer [REDACTED] assertion is that he did not assist with placing [REDACTED] into custody, as such this allegation is not sustained.

3. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you punched [REDACTED] on the face;

COPA finds this allegation not sustained. [REDACTED] alleges that multiple officers beat him when he was at the gas station. Officer [REDACTED] did not assist with placing [REDACTED] into custody at the gas station. There is no independent evidence to support [REDACTED] assertions, neither is there independent evidence to support Officer [REDACTED] assertion that he did not assist with placing [REDACTED] into custody. As such, this allegation is not sustained.

4. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you placed a knee onto [REDACTED] neck;

COPA finds this allegation not sustained. According to Officer [REDACTED] he did not assist with placing [REDACTED] into custody. While [REDACTED] asserts that officers beat him, there is no independent evidence to support this assertion, as such, COPA finds the allegation not sustained.

5. It is further alleged that while at the [REDACTED] district station, Officer [REDACTED] denied [REDACTED] medical attention.

COPA finds this allegation not sustained. While [REDACTED] states that he requested medical attention twice, he does not state that he asked Office [REDACTED] specifically. With no independent evidence to support [REDACTED] assertion, COPA finds the allegation not sustained.

6. It is further alleged that while at [REDACTED] District Station you placed him in an unsanitary cell with smeared feces and urine on the walls.

COPA finds this allegation not sustained. [REDACTED] states that on the night he was arrested, he was taken back to the district and placed in an unsanitary cell. Officer [REDACTED] denied placing [REDACTED] into an unsanitary cell. Officer [REDACTED] was present the day of [REDACTED] arrest, but he does not recall [REDACTED] he also stated that at no time would a prisoner be placed in an unsanitary cell. Detention Aide [REDACTED] and Detention Aide [REDACTED] were also present the day [REDACTED] was arrested, but they do not recall [REDACTED] and [REDACTED] also stated that a prisoner would not be placed in an unsanitary cell. There is no independent evidence to support [REDACTED] assertion, so COPA finds the allegation not sustained.

Officer [REDACTED] Allegations

1. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you kicked [REDACTED] about the face, body, head, stomach and legs;

COPA finds this allegation not sustained. According to [REDACTED] on the date of the incident, several officers got out of their vehicle with their weapons drawn and pointed at [REDACTED] was scared so he ran. The officers ordered [REDACTED] to stop, but he ignored their orders. [REDACTED] ran to a gas station and that is where several officers beat and kicked him. According to Officer [REDACTED] he assisted with the pursuit of [REDACTED] but did not assist with placing [REDACTED] into custody. When Officer [REDACTED] observed [REDACTED] at the gas station, he was already in custody. There is no independent evidence to support Officer [REDACTED] assertion that he did not assist with [REDACTED] placement into custody, nor is there independent evidence to support [REDACTED] assertion that he was beat by Officer [REDACTED] as such, COPA finds this allegation not sustained.

2. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you punched [REDACTED] about the body, head, and legs;

COPA finds this allegation not sustained. According to [REDACTED] officer punched him and beat him when he was at the gas station. Officer [REDACTED] assertion is that he did not assist with placing [REDACTED] into custody, as such this allegation is not sustained.

3. It is reported in civil suit# [REDACTED] filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you punched [REDACTED] on the face;

COPA finds this allegation not sustained. [REDACTED] alleges that multiple officers beat him when he was at the gas station. Officer [REDACTED] did not assist with placing [REDACTED] into custody at the gas station. There is no independent evidence to support [REDACTED] assertions, neither is there

independent evidence to support Officer ██████ assertion that he did not assist with placing ██████ into custody. As such, this allegation is not sustained.

4. It is reported in civil suit# ██████ filed on October 14, 2015, that on September 04, 2013 at 6659 S. Halsted at 7:49p.m. you placed a knee onto ██████ neck;

COPA finds this allegation not sustained. According to Officer ██████ he did not assist with placing ██████ into custody. While ██████ asserts that officers beat him, there is no independent evidence to support this assertion, as such, COPA finds the allegation not sustained.

5. It is further alleged that while at the ██████ district station, Officer ██████ denied ██████ medical attention.

COPA finds this allegation not sustained. While ██████ states that he requested medical attention twice, he does not state that he asked Office ██████ specifically. Officer ██████ also stated that he never heard ██████ request medical attention. With no independent evidence to support ██████ assertion, COPA finds the allegation not sustained.

6. It is further alleged that while at ██████ District Station you placed him in an unsanitary cell with smeared feces and urine on the walls.

COPA finds this allegation not sustained. ██████ states that on the night he was arrested, he was taken back to the district and placed in an unsanitary cell. Officer ██████ did not transport ██████ and did not place him in a cell. Officer ██████ was present the day of ██████ arrest, but he does not recall ██████ he also stated that at no time would a prisoner be placed in an unsanitary cell. Detention Aide ██████ and Detention Aide ██████ were also present the day ██████ was arrested, but they do not recall ██████ and ██████ also stated that a prisoner would not be placed in an unsanitary cell. There is no independent evidence to support ██████ assertion, so COPA finds the allegation not sustained.

Sergeant ██████ allegation

1. It is reported in civil suit# ██████ that on September 04, 2013 at 6659 S. Halsted during the arrest of ██████ you failed to intervene and order the officers to stop "beating" him.

COPA finds this allegation not sustained. According to ██████ he was beat by several officers while sergeants watched it happened and did not try to stop the officers. According to Sergeant ██████ he responded to a call about a man with a gun. By the time Sergeant ██████ reached the house the call was about, he heard over the radio that the offender was in custody. Sergeant never saw ██████ There is no independent evidence to support ██████ assertion that Sergeant ██████ was present during his encounter with the police. There is also no independent evidence to prove or disprove Sergeant ██████ assertion that he was not involved in the apprehension of ██████ as such this allegation is not sustained.

Sergeant [REDACTED] allegation

1. It is reported in civil suit# [REDACTED] that on September 04, 2013 at 6659 S. Halsted during the arrest of [REDACTED] you failed to intervene and order the officers to stop "beating" him.

COPA finds this allegation not sustained. According to [REDACTED] he was beat by several officers while sergeants watched it happened and did not try to stop the officers. According to Sergeant [REDACTED] on the date of the incident he responded to a call about a man with a gun. When Sergeant [REDACTED] arrived at the scene, he observed [REDACTED] sitting on the porch, but then [REDACTED] got up and ran. Sergeant [REDACTED] ran around the house to try to catch [REDACTED] but [REDACTED] had already began running through the alley. Sergeant [REDACTED] continued to pursue [REDACTED] ended up running to a gas station. According to Sergeant [REDACTED] was struggling a little as the officers were trying to place him into custody. Sergeant [REDACTED] did not observe any officers beating [REDACTED] There is no independent evidence to support [REDACTED] assertions, nor is there independent evidence to support Sergeant [REDACTED] assertions, as such this allegation should be not sustained.

Sergeant [REDACTED] allegation

1. It is reported in civil suit# [REDACTED] that on September 04, 2013 at 6659 S. Halsted during the arrest of [REDACTED] you failed to intervene and order the officers to stop "beating" him.

COPA finds this allegation not sustained. According to [REDACTED] he was beat by several officers while sergeants watched it happened and did not try to stop the officers. According to Sergeant [REDACTED] she responded to a call about a man with a gun. When she arrived at the scene, she saw officers pursuing [REDACTED] and she joined in on the pursuit. However, she stopped her pursuit of [REDACTED] when she reached Officer [REDACTED] because he had retrieved a gun that [REDACTED] had. Sergeant stayed on Union Street with Officer [REDACTED] to make sure he was okay. Sergeant [REDACTED] did not witness the apprehension of [REDACTED] neither did she see [REDACTED] after he was apprehended. There is no independent evidence to support [REDACTED] assertion that Sergeant [REDACTED] was present during his encounter with the police. There is also no independent evidence to prove or disprove Sergeant [REDACTED] assertion that she was not involved in the apprehension of [REDACTED] as such this allegation is not sustained.

VI. CONCLUSION

Based on the analysis set forth above, COPA makes the following findings:
