UPON ARRIVAL R/O'S WERE MET BY ██████████ (VICTIM) AND ██████████ (VICTIM) WHO RELATED THAT THEY WERE INVOLVED IN THE ACCIDENT. FURTHERMORE, VICTIMS RELATED THAT WHILE STOPPED TO LET THE PEDESTRIANS CROSS THE STREET THEIR VEHICLE WAS STRUCK ON THE REAR BY ANOTHER VEHICLE (2003 LEXUS SEDAN DARK BLUE COLOR).
