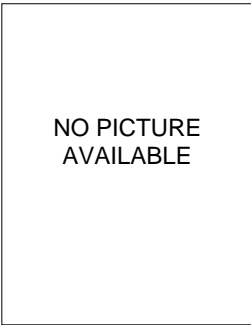

IN SUMMARY, OFFENDER PLACED IN CUSTODY AFTER A/O S WERE INFORMED BY DET. MEISTER #20423 THAT ON 09JUNE2020 RECORDED UNDER RD #JD258314, AARON MC CLELLAND(VICTIM) WAS CONFRONTED BY A MALE BLACK NKA THOMAS, CHRISHAWN ARMED WITH A SEMI-AUTOMATIC HANDGUN WHO WAS WEARING A SURGICAL MASK AND POINTED SAID FIREARM TOWARDS AARON MCCLELLAND(VICTIM) FACE. AN ARMED CONFRONTATION OCCURED WHERE AARON MCCLELLAND(VICTIM)AND OFFENDER WERE BOTH STRCUK BY GUNFIRE. CHRISHAWN THOMAS(OFFENDER) THEN FLED SOUTHBOUND ON ARTESIAN IN A DARK COLORED FOUR DOOR VEHICLE. CHRISHAWN THOMAS(OFFENDER) ARRIVED AT ST. BERNARD HOSPITAL WITH MULTIPLE GUNSHOT WOUNDS TO HIS LOWER EXTREMITIES. BLOOD TRAIL ONSCENE SWABBED BY CPD ET. OFFENDER WAS SWABBED AT THE HOSPITAL. THROUGH DETECTIVES INVESTIGATIONS THEY WERE NOTIFIED BY ISP FORENSIC SERVICES OF DNA PROFILES OF SWABS TAKEN FROM SCENE AND FROM CHRISHAWN THOMAS WERE COMPARED AND IT WAS SUBSEQUENTLY DETERMINED TO BE CONSISTENT WITH THAT OF THOMAS, CHRISHAWN.
