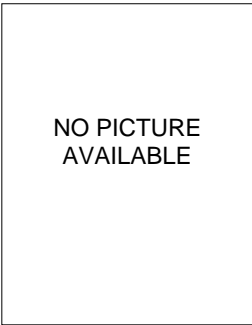

	<p>Event#: 09552. P.O. Ardolino #9874 and P.O. Marano #10226 responded to a person with a gun call at Moran Park (5727 S. Racine ave) with a description of red shirt and red hat. P.o.s observed an individual matching the description when a foot pursuit ensued going east-bound on 57th from Racine. During the foot pursuit, offender pointed and subsequently fired multiple rounds using a handgun (Smith and Wesson 9mm model:SW9VE serial#: [REDACTED] at fully uniformed Chicago police officers P.O. Ardolino #9874 and P.O. Marano #10226 intending to kill/do great bodily harm to said P.O.s. Offender was then located and placed into custody at 5616 S. Aberdeen ave.
