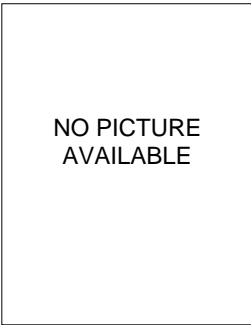

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT #03834 THIS IS A BODY WORN CAMERA INCIDENT. IN SUMMARY, A/O'S RESPONDED TO A CALL FOR INFO. FOR POLICE REGARDING A VEHICLE LOCATED AT THE ABOVE LISTED ADDRESS. UPON ARRIVAL, A/O'S WERE PROCESSING THE STOLEN VEHICLE WHICH WAS REPORTED STOLEN IN A VEHICULAR HIJACKING WHEN AN UNKNOWN SUBJECT WALKED UP AND ENTERED THE STOLEN VEHILCE. THE SUBJECT ATTEMPTED TO START THE VEHICLE AND LEAVE THE SCENE. A/O'S ATTEMPTED TO REMOVE THE OFFENDER FROM THE VEHICLE WHEN THE SUBJECT NOW PROPERLY IDENTIFIED AS LOVELLE, JORDAN (IR#1874063) VIGOROUSLY RESISTED ARREST WHEN A/O'S ATTEMPTED TO PLACE HIM IN CUSTODY. THE ARRESSTEE STRUCK A.O. CARAMUSA SEVERAL TIMES ABOUT THE CHEST KNOCKING THE A/O'S CAMERA OFF HIS VEST. A/O'S SUCCESSFULLY TOOK DOWN THE OFFENDER AND PREFORMED EMERGENCY HANDCUFFING, EFFECTIVELY PLACING THE ARRESSTEE IN CUSTODY. ONCE IN CUSTODY, THE SUBECT WAS SEARCHED AND A/O'S FOUND NARCOTICS (SUSPECT CRACK-COCAINE AND SUSPECT HEROIN), THE A/O'S PLACED THE ARRESSTEE IN BEAT 2531 VEHICLE TO BE FURTHER PROCESSED AT THE 025TH DISTRICT STATION. ONCE 2531 ARRIVED AT THE DISTRICT STATION AND ATTEMPTED TO REMOVE THE ARRESTEE FROM THE VEHICLE, THE ARRESSTEE PRODUCED A CLOCK 43 SEMI-AUTOMATIC PISTOL AND FIRED SAID WEAPON AT P.O. CLOHERTY MULTIPLE TIMES. THE OFFENDER THEN EMERGED FROM THE VEHICLE AND ENGAGED MULTIPLE OFFICERS IN A GUN FIGHT STRIKING A TOTAL OF THREE OFFICERS. THE OFFENDER WAS WOUNDED BY RETURN FIRE AND PLACED BACK INTO CUSTODY AND HIS WEAPON WAS RECOVERED.
