**NARRATIVE**

EVENT#16916, BODY WORN CAMERA RECORDED EVENT, IN SUMMARY, R/OS RESPONDED TO A ROBBERY JUST OCCURED AT THE ABOVE LOCATION AT THE BP GAS STATION. R/OS SPOKE WITH ██████████ (VICTIM) WHO RELATED THAT HE WAS INSIDE THE GAS STATION AND ██████████ (VICTIM) WAS IN THE PASSENGER SIDE OF THE VEHICLE SLEEPING. AT WHICH POINT, ██████████ (VICTIM) RELATED THAT AN UNKNOWN MALE BLACK (NO FURTHER DESCRIPTION) ENTERED THE VEHICLE AND DROVE ONTO ROOSEVELT WITH THE VICTIM INSIDE THE CAR. THE OFFENDER THEN DISPLAYED A GUN AT THE VICTIM AND SAID "GET THE FUCK OUT BEFORE I KILL YOU." ██████████ (VICTIM) THEN EXITED THE VEHICLE AND THE ABOVE OFFENDER FLED E/B ONTO ROOSEVELT. 102S RELATED THAT FOOTAGE OF THE INCIDENT SHOWED THE OFFENDER FLEEING S/B ON LAKESHORE DR. THE VEHICLE IS A WHITE 4 DOOR PORSCHE MACAN. ██████████ (VICTIM) RELATED THE VEHICLE WAS BEING RENTED OFF OF A VEHICLE RIDE SHARING APP "TURO". ██████████ (VICTIM) ALSO RELATED HE COULD SEE AN BLACK SUV FOLLOWING THE VEHICLE BUT COULD NOT DETERMINE THEIR INVOLVEMENT. 102S RELATED THE VEHICLE HAD BEEN SEEN TRAVELING SOUTHBOUND TOWARDS LAKE SHORE DRIVE ON POD CAMERAS 6658, 6508, AND 6129 AT 2330HRS. THE ABOVE VEHICLE IS REGISTERED TO ██████████ ADDRESS OF ██████████. VEHICLE ADDED TO HOT FILE. VIN GIVEN AND EXPLAINED.
