NARRATIVE

EVENT #. ICC & BWC RECORDED POST CRASH. UNIT #1 WAS TRAVELING AT A HIGH RATE OF SPEED E/B ON LAKE IN THE MIDDLE OF ROAD. LAKE ST IS UNDER THE CTA TRACKS AND CTA PILLARS ARE BETWEEN THE TWO EAST AND WEST BOUND LANES. WHILE TRAVELING E/B JUST EAST OF KEDZIE IT STRUCK THE LEFT FRONT FENDER OF UNIT #2 THAT WAS TRAVELING W/B ON LAKE ST. UNIT #2 BARELY GOT OUT OF THE WAY OTHERWISE IT WOULD HAVE BEEN STRUCK HEAD ON. AFTER STRIKING UNIT #2, UNIT #1 LOST CONTROL AND STRUCK A CTA PILLAR ON NORTH SIDE OF STREET. FORCE OF THE IMPACT SWUNG UNIT #1 AROUND FACING W/B IN E/B LANE AND BECAME ENGULFED IN FLAMES. BT #1163C OBSERVED ACCIDENT AND BT #1163A & 1163E HELPED BOTH PASSENGERS OUT OF VEHICLE. DRIVER WAS STILL IN DRIVER SEAT, DOA.. LICENSE PLATES ON VEHICLE CAME BACK TO A 2003 JAGUAR BUT THE VEHICLE IS A 2001 JEEP. BOTH PASSENGERS TRANSPORTED TO CCH. PASSENGER [REDACTED] WAS TAKEN INTO SURGERY IN CRITICAL CONDITION WITH INTERNAL BLEEDING AND R/O'S LATER FOUND OUT SHE WAS PREGNANT AND LOST THE BABY. PASSENGER [REDACTED] HAD TWO BROKEN FEMUR AND ALSO IN CRITICAL CONDITION. R/O'S INVESTIGATION FOUND OUT THE DRIVERS NAME. MAIU FREITAG #18520 NOTIFIED AT 2220 HRS.
