

EVENT#06265. IN SUMMARY *ON BWC* A/O'S OBSERVED THE ABOVE VEHICLE TRAVELING AT A HIGH RATE SPEED AWAY THE VICINITY OF SHOTS FIRE. A/O'S THEN OBSERVED THE VEHICLE COMMITTING MULTIPLE TRAFFIC VIOLATIONS AND CONTINUED TO FOLLOW THE VEHICLE. AS THE OFFENDERS VEHICLE EXITED THE ALLEY A/O'S OBSERVED THE VEHICLE STRIKE ANOTHER VEHICLE THEN COME TO A REST ON A UTILITY POLE.
