INCIDENT NARRATIVE

EVT #13523 THIS IS AN ARREST BY THE AREA 2 VEHICULAR HIJACKING TEAM. IN SUMMARY WHILE IN FULL UNIFORM DRIVING AN UNMARKED SQUAD CAR A/O'S WERE CONDUCTING SURVEILLANCE ON A STOLEN MOTOR VEHICLE (GMC TERRAIN) OUT OF SCHAUMBURG, IL. A/O'S HAD WORKING KNOWLEDGE THAT THIS PARTICULAR VEHICLE WAS ALSO USED IN TWO SEPERATE SHOOTINGS IN THE 022 DIST RECORDED UNDER RD'S #JE202668 AND JE210725. A/O'S WERE STATIONED AT 9223 S COLFAX AVE WHEN A/O'S HEARD SEVERAL LOUD REPORTS COMING FROM THE EAST OF OUR LOCATION. A/O'S IMMEDIATELY RELOCATED TO 9200 S COLFAX AT WHICH TIME BEAT 7647A RADIOED IN A 10-1 SHOTS FIRED AT THE POLICE. BEAT 7647A FURTHER RELAYED THAT TWO M/1'S FLED FROM THE SCENE GOING TWO SEPERATE DIRECTIONS E/B AND S/B. A/O'S CONDUCTED A CANVASS FOR THESE OFFENDERS WALKING E/B IN THE COLFAX ALLEY WITH PO GIBBONS AND PO POKROVAC. AT WHICH POINT PO GIBBONS RECOGNIZED AN M/1 WHO WALKED PASS HIS UNMARKED SQUAD CAR (STATIONED AT 9219 S SAGINAW) MOMENTS BEFORE THE LOUD REPORTS OCCURED STANDING IN THE BACKYARD OF 9221 S COLFAX. A/O'S ENTERED INTO THE BACKYARD WHERE THE M/1 NOW KNOWN AS [REDACTED] WAS STANDING ON GROUND LEVEL BY THE BACKDOOR STAIRS TALKING TO TWO F/1'S WHO WERE AT THE TOP OF THE STAIRS. A/O'S CONDUCTED AN INVESTIGATORY STOP AN ASKED OFFENDER [REDACTED] IF HE LIVED AT THAT RESIDENCE TO WHICH HE STATED NO. THE OFFENDER APPEARED VERY NERVOUS, ELUSIVE IN HIS ANSWERS AND HAD HEAVY BREATHING. A/O'S ALSO ASKED THE TWO F/1'S IF THEY KNEW THE OFFENDER TO WHICH NEITHER COULD CONFIRM THAT THEY KNEW HIM. AT WHICH TIME [REDACTED] WAS DETAINED. UPON A/O SEARCHING THE EXTERIOR OF THE HOUSE WHERE THE OUTER BASEMENT DOOR IS LOCATED A/O CAME UPON A BLACK SEMI AUTO HANDGUN WITH A DRUM MAG IN A KIDS WAGON WHICH WAS APPROXIAMATELY 3-5FT AWAY FROM THE OFFENDER. THE HOME OWNER CONFIRMED THAT THE GUN WASN'T HERS AND SHE DIDN'T HAVE ANY KNOWLEDGE OF A HANDGUN BEING IN THAT AREA. THE OFFENDER WAS PLACED IN CUSTODY AND TRANSPORTED TO 005 DIST FOR PROCESSING. PARENT NOTIFIED AT 2043HRS. SVU NOTIFIED WALKER #21468 BT #5286 @ 0439. ISR COMPLETED #010994797. NO GIPP, NO WANTS OR WARRANTS, NO PAROLE OR PROBATION.
