Narrative

In Summary: On 27 JUL 21 at 1523 hours, I, Officer J. Siatta #265, along with Capt. Urbanek #185, Sgt. Wheaton #166, Officers Mottl #214, Banske #173, Flores #255, Lucius #230, responded to 1653 Sibley Blvd. for the report of an Officer involved shooting involving Chicago PD, US Marshalls, and Illinois State Police members of the US Marshalls Fugitive Task Force.

Prior to my arrival Officer Mottl advised he was on scene and that there was one person who had been shot inside 1653 Sibley Blvd., ROC and RO BBQ. The person shot was later identified as [Personal Privacy] and was transported by Calumet City Fire Department Paramedics Joe Okichich, Cesar Garcia, Nick Panczuk and EMS Student Adam Staszewski to Christ Hospital where [Per] was pronounced deceased at 1619 hours by Dr. Omi.

Capt. Urbanek, Officers Flores, Banske, Lucius, and I maintained the scene while investigators Erickson #199, Burnett #197, La Fave #242, and Dimitroff #243, as well as Chief Kolosh #183 and Commander Govert #196 arrived on scene.

Outside of the building I spoke to 3 people who where inside the building during the incident, [Personal Privacy] [Person] advised that [Per] was inside the bathroom during the incident and hid on the ground until [Per] was told to come out. [Personal] advised that [Per] was asleep on the couch near the back of the building and was woken up by gunshots. [Person] was working the front counter and unlocked the door for the Officers to enter, then hid behind the counter.

Officer Lucius maintained the crime scene log. Master Sgt. Thomas #5070 of ISP Public Integrity Unit responded to the scene.

I contacted the Cook County Medical examiners officer and spoke to Inv. Cucero #69, I gave Cucero the information I had collected and a case was opened. (Case# ME2021-07081)

ISP Crime Scene Investigators Klingen #6471, and Myers #6297 took over the scene to be processed. Upon their completion the scene was turned over to the owner Vernado Parker. (Tx# 312-446-7177)
