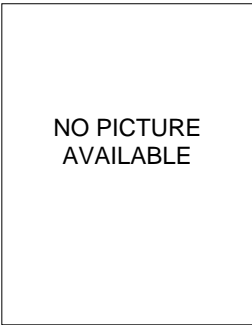

bwc recorded event Event#15728 Stated subject was arrested on signed complaints in that after firing multiple shots and striking P.O. French #15013 in the head and causing a fatal injury. P.O. Yanez #16022 was also struck in the head causing great bodily harm. The arrestee also pointed a firearm at P.O. Blas #14751, placing him in fear of receiving a battery. A/o's placed the offender into custody at 6320 s Bell Ave. A/o's observed a GSW to the offenders left chest at which time he was transported to Christ Hospital by CFD ambulance #8. The offender was admitted into the hospital and treated by Dr. Tootla.
