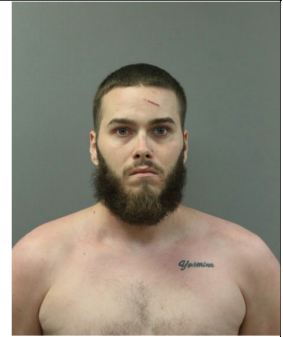

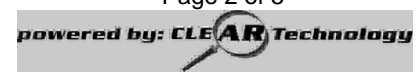

**ARREST REPORTING**

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EV# 01429 This is a body worn camera event. In summary, Beat 4606 SWAT Officers Jonas #5069 and J.Murphy #4360 responded to a call of shots fired at and by the police at the address of Nagle AVE and Higgins Ave. The investigation revealed that the above offender was driving a black Dodge vehicle (listed in arrest report) recklessly and subsequently crashed the vehicle and fled from the vehicle on foot.

INCIDENT NARRATIVE

Arresting officers assisted Beat 4737 Canine Officer Leja #15475 in a systematic search for offender/driver. Based on the information from Canine Officer Leja #15475 and first responding Officer Mersch #14653, Officer Jonas #5069 then decided to search the roof tops. With assistance of CFD ladder, Officer Jonas #5069 was able to clear two roof tops. During the search of the third roof top Officer Jonas #5069 found a person matching the description of arrestee. Officer J.Murphy #4360 soon followed Officer Jonas #5069 up the ladder and was able to place arrestee into custody without incident on the rooftop. Further investigation by the assigned IRT Detectives (Campbell #21279) revealed that he was the operator of the Dodge vehicle.

Once in custody PO Mersch #14653 positively identified the arrestee (on BWC). CFD Amb 39 transported offender to Community First with Beat 2434 accompanying. PO Mersch #14653 issued traffic citations [REDACTED] for reckless driving, leaving scene of property damage, no valid DL and operating uninsured vehicle. Arrestee has \$500.00 USC on his person. \$2688.08 USC was inventoried under INV# [REDACTED]. Pursuant to executing a search warrant# [REDACTED], Multiple knotted baggies containing suspect cocaine, packaged for individual sale, (Est. street value: \$5000 USC), additionally multiple bags containing suspect cannabis, packaged for individual sale, (Est. street value: \$9000 USC) was recovered from the listed Dodge vehicle. The suspect narcotics were recovered by evidence technicians and inventoried. Name check clear, no wants or warrants.
