**INCIDENT NARRATIVE**

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

Event #090838, BWC activated, above offender was placed in custody, after he was observed in possession of a firearm. The above offender was approached by the victim officers at which time the offender retrieved the firearm (Glock 19, 9mm semi-automatic pistol, serial number [REDACTED] blue steel, 4 inch barrel) as the victim officers (in full CPD field uniform) clearly directed the offender multiple times to not retrieve the weapon. These actions of the offender placed the victim officers in substantial fear of receiving an aggravated battery that could result in death or great bodily harm. The above offender was placed in custody and transported to Stronger Hospital by CFD EMS #45 for injuries sustained during this incident. A custodial search of the offender revealed him to be in possession of a small quantity of suspect MDMA from the offender.
