EVENT #09292, IN SUMMARY WHILE IN AN OFFICIAL POLICE CAPACITY DRIVER OF UNIT #2 WAS STRUCK BY UNIT #1 WHILE ATTEMPTING TO CURB VEHICLE WANTED FOR AGGRAVATED BATTERY TO PO LISTED UNDER RD # JF-403950. AFTER STRIKING UNIT #2, UNIT #1 PROCEEDED TO STRIKE UNIT #3 WHO ALSO WAS IN AN OFFICIAL POLICE CAPACITY, AND THEN FLED LOCATION ONTO NW/B I-90. PASSENGER OF UNIT #2 COMPLAINED OF A SORE NECK AND MEDICAL ATTENTION REFUSED AT THIS TIME BY ALL OTHER INDIVIDUALS INVOLVED IN TRAFFIC CRASH.
