**INCIDENT NARRATIVE**

EVENT [REDACTED] BWC RECORDED INCIDENT. A/OS AND ASSISTING UNITS WERE RESPONDING TO A CALL OF SHOTS FIRED AT THE MOBIL GAS STATION LOCATED AT ASHLAND AVE AND ROOSEVELT RD. THE CALLER/VICTIM SMITH JR, HODGES RELATED THAT A MALE HISPANIC THIN BUILD WEARING A BLACK COAT, GRAY HOODIE STOLE VICTIMS CAR, A RED 2018 JEEP IL PLATE [REDACTED] AND CRASHED IT AT 1535 W ROOSEVELT RD. ARRESTEE THEN FIRED SEVERAL SHOTS IN THE DIRECTION OF VICTIM AND RAN E/B FROM THE LOCATION. WHILE TOURING THE AREA A/OS OBSERVED ARRESTEE MATCHING THE DESCRIPTION GIVEN BY VICTIM WALKING N/B ON 1100 BLK SOUTH THROOP. A/O POLKOWSKI 8941 EXITED THE PATROL VEHICLE, APPROACHED THE ARRESTEE AND TOLD HIM TO STOP. ARRESTEE BEGAN TO RUN AWAY FROM A/O N/B ON THROOP ST, TRIPPED ON SNOW AND FELL AFTER RUNNING APPROXIMATELY 20 FEET. A/O ALONG WITH BEAT 1233 DETAINED ARRESTEE. A/O POLKOWSKI RECOVERED AN UNLOADED BLACK IN COLOR SMITH AND WESSON M&P 40C .40CAL SEMIAUTOMATIC HANDGUN SERIAL NUMBER [REDACTED] WITH AN EMPTY MAGAZINE INSERTED IN A BLACK HOLSTER FROM ARRESTEE'S WAISTBAND, INVENTORY [REDACTED] AND [REDACTED] ARRESTEE WAS RELOCATED TO 1535 W ROOSEVELT RD WHERE HE WAS POSITIVELY IDENTIFIED BY VICTIM. ARRESTEE WAS TRANSPORTED TO AREA 3 FOR PROCESSING. DURING CUSTODIAL SEARCH AT AREA 3 DET. CASASANTO RECOVERED A CLEAR KNOTTED BAG CONTAINING A WHITE ROCK LIKE SUBSTANCE, SUSPECT COCAINE, WEIGHING AT APPROX 1 GRAM FROM ARRESTEE'S FRONT RIGHT PANTS POCKET.
