THIS IS A BUREAU OF INTERNAL AFFAIRS / CIS INVESTIGATION EV#05309 In summary, on 23-Feb-2023 at approximately 2253 hrs, in baggage area #6 at Midway Airport, located at 5701 S Cicero Ave Chicago, IL [O] MOORE, SHAWN battered [V] HERNANDEZ, JAIME, in that he struck the subject in the head with a Chicago Police Dept. issued radio without justification or provocation, causing a laceration to the scalp of the victim. During an audio recorded interview with COPA investigator Brian Killen, the victims brother recorded interview with copy in the floor at Midway Airport. [V] HERNANDEZ, JAIME went on to relate that he was awakened by a police officer now known as [O] MOORE, SHAWN, who told him to wake up and leave the airport. [V] HERNANDEZ, JAIME told [O] MOORE, SHAWN that he had nowhere else to go and then asked if he could just stay there for the night. [V] HERNANDEZ, JAIME stated at which time [O] MOORE, SHAWN struck him in the head twice causing it to bleed. [V] HERNANDEZ, JAIME denies throwing anything at [O] MOORE, SHAWN, or making any racist comments to him. This incident was captured in its entirety on recovered airport surveillance video.
