EVENT# 00426 INCIDENT WAS CAPTURED ON VIDEO AND BOOKMARKED ON CHICAGO DEPARTMENT OF AVIATION CAMERA SYSTEM. IN SUMMARY, P.O. S. MONROE #18901 RELATED THAT WHILE ON ROUTINE PATROL A SOUTHWEST EMPLOYEE INFORMED HIM THAT AN UNKNOWN HOMELESS PERSON WAS DRINKING A BEER AND DISTURBING PASSENGERS WHO WERE WAITING FOR THEIR LUGGAGE AT THE BAGGAGE CAROUSEL. P.O. MONROE #18901 LOCATED THE HOMELESS PERSON, NOW KNOWN AS HERNANDEZ, JAIME , AND ASKED HIM TO LEAVE THE AIRPORT. A CONFRONTATION OCCURRED AT WHICH TIME P.O. MONROE #18901 STRUCK THE HOMELESS PERSON OVER THE HEAD WITH HIS POLICE RADIO. HERNANDEZ, JAIME SUSTAINED A LACERATION TO HIS HEAD AS A RESULT. P.O. MONROE REQUESTED FOR EMS. CFD AMB #54 ARRIVED ON SCENE AND TRANSPORTED TO HOLY CROSS HOSPITAL FOR TREATMENT. HERNANDEZ, JAIME IS BEING TREATED BY DR. [REDACTED] DR. [REDACTED] STATES THAT HERNANDEZ, JAIME BLOOD RESULTS SHOW A HIGH LEVEL OF ALCOHOL IN HIS IN HIS BLOOD RESULTS AND THAT HIS HEAD LACERATION WILL REQUIRE 5-6 SUTURES. PER SGT T. WARE #2331, HERNANDEZ, JAIME IS NOT BEING TAKEN INTO CUSTODY AT THIS TIME DUE TO HIS INJURIES REQUIRING MEDICAL TREATMENT AND HIS LEVEL OF INTOXICATION. R/O REQUESTED AN E.T.
