EVENT# [REDACTED]-BWC INCIDENT- Beat 1064B was in the process of arresting two offenders for a UUW under [REDACTED] when above subject and another [REDACTED] (CB# [REDACTED]) entered the mouth of the alley and fired a handgun multiple times at the officers. Beat 1064B engaged in a foot pursuit east on 23rd St while giving a flash message over the radio. A/O's observed the the above offender at the above address in the east alley and detained without incident. A show-up was conducted with positive ID at 2305hrs. A firearm (Ruger LCP II, with a laser sight, extended magazine, .380, serial [REDACTED], loaded with an unknown amount of live rounds) was recovered at [REDACTED] blvd in the immediate flight path of the offenders to be recovered by the ETs. Beat H213 transported offender to Area 4 for further processing. Name check clear, no wants/warrants.
