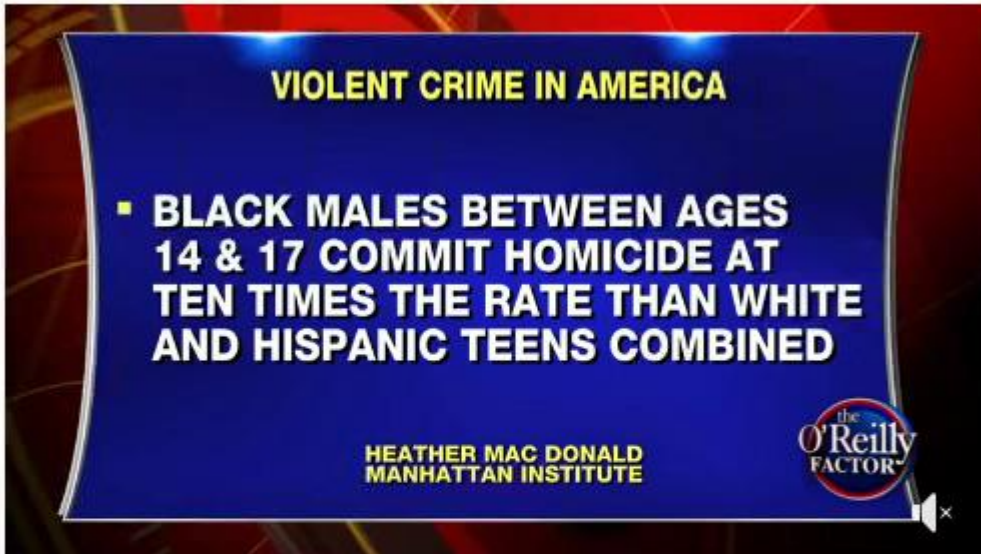
Figure 18, found in Att. 18: Pg. 3

Per Officer Englehart, he shared the above photo as commentary on the United States Constitution, "which says only a US citizen can vote."<sup>5</sup> What asked why he did not believe this comment to be racial when the individuals pictured appear to be Hispanic, Officer Englehart related "it could be anybody from any country, it doesn't have to be just Hispanic."<sup>6</sup> When asked about those pictured above, Officer Englehart stated he was commenting that only citizens can vote and did not know whether the people pictured were citizens. Officer Englehart stated he did not know whether those seen above are Hispanic and they may be Italians, who can be darker complexed.

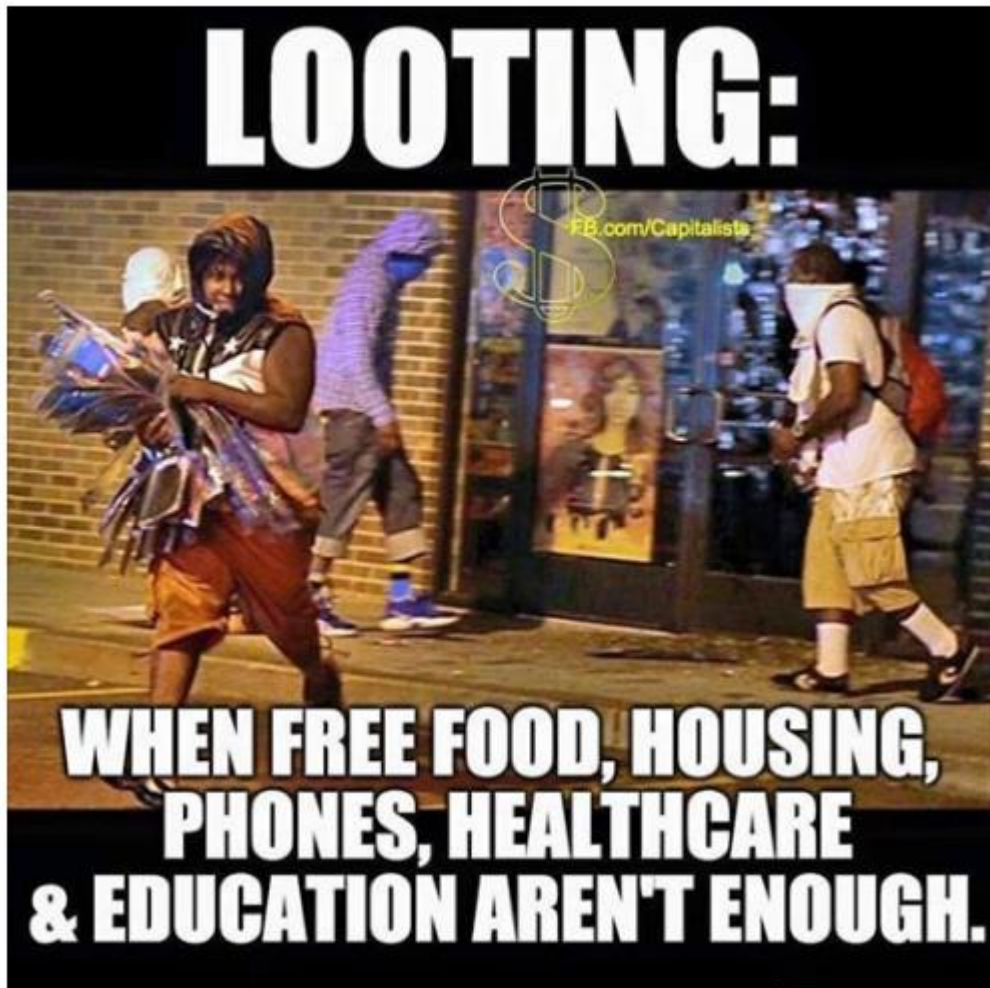

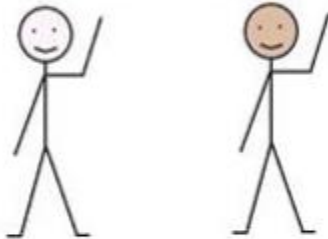
Figure 30, found in Att. 18: Pg. 20



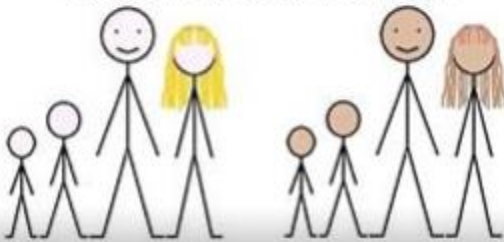
