a. Interviews

This Investigator viewed the Body Worn Camera footage for this event and determined that the accused officers did not need to give a statement to COPA.

b. Digital Evidence

This Investigator viewed Body Worn Camera for the accused and there is no evidence to corroborate Ms. King’s allegation. To the contrary, the footage shows the accused officers acting in a professional and courteous manner.

VI. ANALYSIS

The Body Worn Camera footage for this incident proved that the finding, for the allegation of excessive force, should be Unfounded.
