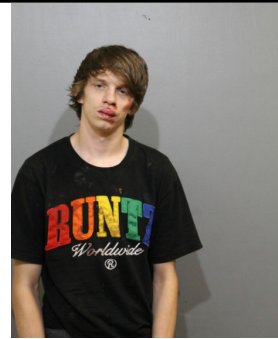

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT# 22244001391 THIS IS A BWC INCIDENT, IN SUMMARY, A/OS WERE RESPONDING TO A CALL OF DRAG RACERS AT 95TH AND EWING. A/OS HAD PRIOR KNOWLEDGE THAT THE DRAG RACERS WERE DRIVING EXTREMELY RECKLESS AND HAD LASER POINTERS POINTED AT OTHER OFFICERS ON SCENE. A/OS ARRIVED ON SCENE TO FIND AN UNKNOWN MASKED OFFENDER TRYING GET ON TOP OF MARKED SQUAD-CAR VEHICLE#7826 BEARING ILLINOIS MUNICIPAL PLATE (MP18904). A/OS HAD PRIOR KNOWLEDGE THAT FELLOW OFFICERS WERE SEATED INSIDE OF THE CAR. BY TRYING TO CLIMB UP ONTO THE TOP OF THE SQUAD CAR THE UNKNOWN MASKED OFFENDER WAS OBSTRUCTING THE DUTIES OF OFFICER OMACHI# 10623 AND OFFICER HEUER #18239, WHO WERE INSIDE THE VEHICLE, BY NOT ALLOWING THEM TO DO THEIR JOB OF DISPERSING THE LARGE CROWD. FOR THE SAFETY OF THE OFFICERS INSIDE OF THE SQUAD VEHICLE, A/OS GAVE VERBAL COMMANDS TO THE ARRESTED OFFENDER KNA NOVORITA, JORDAN (M/2/19YOA) TO GET OFF OF THE VEHICLE. ARRESTED NOVORITA DID NOT COMPLY TO VERBAL COMMANDS. AT THIS POINT, A/OS PERFORMED AN EMERGENCY TAKEDOWN. OFFENDER NOVORITA BEGAN TO RESIST ARREST BY FLAILING HIS ARMS, STIFFENING HIS BODY AND KICKING ERRATICALLY TO EVADE ARREST NOT ALLOWING OFFICERS SRODULSKI #18452, OMACHI #10623, HEUER #18239 AND LINDGREN #14018 TO APPLY HANDCUFFS. A/OS WERE ABLE TO OVERCOME THE OFFENDERS FLAILING ARMS, STIFFENING OF HIS BODY AND KICKING TO DETAIN THE OFFENDER AT 0055 HRS. OFFENDER NOVORITA WAS PLACED INTO CUSTODY AT 0056 HRS AND TRANSPORTED TO THE 004TH DISTRICT STATION FOR FURTHER PROCESSING BY BEAT 0431 (WAGON) AT 0057 HRS. ONCE ARRESTED NOVORITA HAD ARRIVED TO THE STATION, OFFENDER ASKED A/OS TO BE TAKEN TO THE HOSPITAL FOR HIS INJURIES SUFFERED TO THE MOUTH AND NOSE. BEAT 0431 (WAGON) THEN TRANSPORTED THE OFFENDER TO SOUTH SHORE HOSPITAL FOR FURTHER TREATMENT OF HIS INJURIES AT 0109 HRS. MD DR. [REDACTED] OF SOUTH SHORE HOSPITAL LISTED OFENDER NOVORITA IN STABLE CONDITION. ARRESTED DID NOT MAKE ANY PHONE CALLS DUE TO NEVER BEING PLACED INTO THE PROCESSING ROOM AT THE 004TH DISTRICT STATION, HOWEVER HE WAS TAKEN TO SOUTH SHORE IMMEDIATELY FOLLOWING THE INCIDENT FOR MEDICAL TREATMENT AND DID NOT HAVE ANY PHONE NUMBERS MEMORIZED TO CALL FROM THE HOSPITAL. AREA M2 SERGEANT WINSTEAD #783 BT. 5290 NOTIFIED AT 0227 HRS. ET ORDERED FOR SQUAD VEHICLE AND FOR PICTURES OF OFFENDERS INJURIES VIA CW2 AT 0229 HRS. PRISONER PERSONAL PROPERTY INVENTORIED UNDER INV# 15160083. PRISONER JEWELRY INVENTORIED UNDER INV# 15160084. PROPERTY HOLD FOR INVESTIGATION UNDER INV #15160176 ARRESTED NOVORITA DID NOT HAVE ANY USC ON HIS PERSON AT THE TIME OF ARREST. PRISONER MADE ONE PHONE CALL AT 0442 TO [REDACTED] AND THEN REFUSED TO MAKE ANY OTHER PHONE CALLS.
