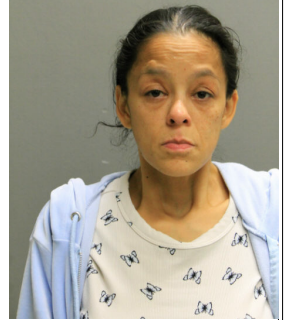

Officers approached for a field interview, at which time the offender pointed a black semi-automatic handgun at the officers and pulled the trigger, there by placing the officers in the fear of receiving great bodily harm, and or death. The offender was identified by video and physical evidence left at the scene. On todays date A/O's observed offender walking at the location of 9800 s Avenue L.
