OPA conducted a full and complete investigation of this matter, including the interview of all pertinent civilian and officer witnesses, and the collection and review of digital, documentary, and forensic evidence. As part of COPA's ongoing efforts to increase case closure capacity, certain cases are summarized more succinctly in a Modified Summary Report of Investigation, pursuant to COPA Guideline Modified Summary Report of Investigation Template and Approvals, effective February 13, 2019.

II. SUMMARY OF EVIDENCE

On December 17th, 2020, COPA received a complaint from he was involved in a traffic stop with Chicago Police Officers Joseph Shannan (PO Shannan) and Thomas McDonnell (PO McDonnell). The incident occurred on December 13th, 2020, at approximately 09:37pm, at or near 7100 S. Rockwell Street. Per he was pulled over for a simple traffic stop and then he was pulled out of his car. alleged the accused officers used excessive force when physically removing him from his vehicle. On March 24th, 2021, provided a recorded interview to COPA Investigators via phone, due to the Covid-19 pandemic.² In his interview, stated he was pulled over by two Chicago Police Officers who claimed his license place was upside down and had a broken stated he gave the officer his driver's license and insurance. stated the officer saw an "old rusty razorblade with some brown and white stuff on it"3. stated the officer then ordered him out of the vehicle to which why he had to get out if he gave him his driver's license and insurance. According to the officer told him he had to get out "because I said so" and proceeded to pull him out of the stated a sergeant then arrived and assisted the officers in pulling him out of his vehicle⁴. stated he asked the officers why he was being arrested and he was not stated he believed he should not be arrested because the razor blade given a reason. was on the outside of the vehicle, and he had given the officers his license and insurance. COPA reviewed available Body Worn Camera (BWC) video, the recorded statement from , and documentary evidence including, but not limited to CPD Arrest records, Tactical Response Reports (TRR), Crime Scene Report(s). According to CPD Arrest Report #30013304, PO Shanahan and PO McDonnell initially for driving with his front license plate not attached properly. 5 BWC of the event showed PO Shanahan approached the vehicle on the driver's side and informed him he pulled him over because "his plate in the front is all jacked up. It's up and down vertically". As PO Shannahan approached the vehicle, he also noticed a razor blade on the hood⁷. PO Shanahan step out of the vehicle to conduct a narcotics investigation. refused and stated he didn't have to step out of the vehicle because he gave his driver's license and insurance⁸. who had a female passenger with him in the vehicle, refused to step out of the vehicle and requested a sergeant to the scene. At approximately 09:47pm, Sergeant John Conneely (Sgt. Conneely) arrived on the scene to speak with Sgt. drivers license was valid at the time of the stop.

he was given a lawful order to step out of the vehicle to which legally he must				
comply ⁹ . was given this order several times yet refused to step out of the vehicle. At				
approximately 9:50pm. Who was on the phone with 911, was offered one final				
opportunity to step out of the vehicle or he would be forcibly removed ¹⁰ . At approximately				
09:52pm, Sgt. Conneely, opened the drivers side door and Shanahan and McDonnell attempted to				
remove actively resisted officers' efforts to remove him				
from the vehicle. At approximately 09:54pm, was removed from the vehicle and				
handcuffed. was placed in the back of an unmarked CPD vehicle and transported to				
District 008. The arrest report shows was charged with two (2) counts				
resisting/obstructing an officer; and one (1) count for an ordinance violation regarding the failure				
to properly display the vehicle's license plate. ¹¹				

III. LEGAL STANDARD

For each Allegation COPA must make one of the following findings:

- 1. <u>Sustained</u> where it is determined the allegation is supported by a preponderance of the evidence.
- 2. <u>Not Sustained</u> where it is determined there is insufficient evidence to prove the allegations by a preponderance of the evidence.
- 3. <u>Unfounded</u> where it is determined by clear and convincing evidence that an allegation is false or not factual; or
- 4. <u>Exonerated</u> where it is determined by clear and convincing evidence that the conduct described in the allegation occurred, but it is lawful and proper.

A preponderance of evidence can be described as evidence indicating that it is more likely than not that the conduct reviewed complied with Department policy. See Avery v. State Farm Mutual Automobile Insurance Co., 216 Ill. 2d 100, 191 (2005), (a proposition is proved by a preponderance of the evidence when it has found to be more probably true than not). If the evidence gathered in an investigation establishes that it is more likely that the conduct complied with Department policy than that it did not, even if by a narrow margin, then the preponderance of the evidence standard is met.

Clear and convincing evidence is a higher standard than a preponderance of the evidence but lower than the "beyond-a-reasonable doubt" standard required to convict a person of a criminal offense. See *e.g.*, *People v. Coan*, 2016 IL App (2d) 151036 (2016). Clear and Convincing can be defined as a "degree of proof, which, considering all the evidence in the case, produces the firm and abiding belief that it is highly probable that the proposition . . . is true." *Id.* at ¶ 28.

IV. ANALYSIS AND CONCLUSION

COPA finds the allegation Shanahan and McDonnell improperly stopped UNFOUNDED. In his interview on March 24th, 2021, stated he was pulled over because his front license plate was hanging and a broken taillight 12. Chicago Municipal Code 09-76-160(4) states "Every registration plate shall at all times be securely fastened in a horizontal position to the vehicle for which it is issued so as to prevent the plate from swinging and at a height of not less than 12 inches from the ground, measuring from the bottom of such plate, in a place and position to be clearly visible and shall be maintained free from foreign materials and in a condition to be clearly legible"¹³. As Shanahan initially approached noticed a razor blade on the hood of the vehicle. In his interview on March 24th, 2021, did not dispute the razor blade was on his vehicle and even added the razorblade was covered with rust and a white substance. The aforementioned facts, all documented by body worn camera, would give officers reasonable suspicion to stop vehicle and conduct a preliminary investigatory stop 14. The accused officers were not interviewed by COPA due to the fact the allegations could be conclusively UNFOUNDED by reviewing body worn camera related to the event. COPA finds the allegation Shanahan and McDonnell used excessive force against UNFOUNDED. The body worn camera of the event showed when PO Shanahan vehicle he noticed a razor blade, covered in a white substance, on the approached | hood of the vehicle. At approximately 9:39pm, PO Shanahan asked to exit his vehicle to conduct a narcotics investigation due to the fact a razor blade was found on the hood of his refused and requested a Sergeant to the scene. At approximately 9:47pm, Sergeant Conneely arrived on scene and again requested Washinton to step out of the vehicle. again refused and stated he wanted to call 911. At approximately 09:50pm, Sergeant Conneely offered one last opportunity to step out of his vehicle under his own power. The female passenger, who was in the front passenger seat, complied with the officers' orders and exited the vehicle. once again refused and was forcibly removed from the vehicle by officers at the scene. After officers removed his seat belt, was removed from the driver's side of the vehicle and taken to the ground. appear to sustain abrasions to his head when he was taken to the ground. refused any medical in handcuffs and transported to CPD District 08 Lockup. was cited for improper display of license plates, obstructing, and resisting arrest¹⁵. The accused officers were not interviewed by COPA due to the fact the allegations could be conclusively **UNFOUNDED** by reviewing body worn camera related to the event.
