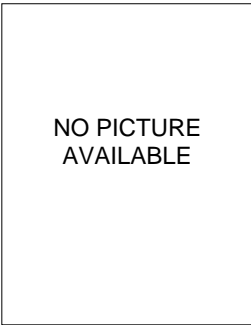

EVENT#04869 IN SUMMARY ON 26 OCT 24 SIDI E. MOHAMED ABDALLAHI DISCHARGED A FIREARM AT VICTIM [REDACTED] STRIKING VICTIM AND CAUSING HIM TO SUSTAIN A GSW TO THE SHOULDER. AFOREMENTIONED OFFENDER FLED THE SCENE. A SHORT TIME LATER OFFENDER RETURNED TO THE SCENE WHILE OFFICERS WERE CONDUCTING THE PRELIMINARY INVESTIGATION ON THE 2700 BLOCK OF W. FARWELL AVE AND FIRED UPON OFFICERS AMBUSHING THEM. AMB 13 WAS ON SCENE TREATING ABOVE VICTIM [REDACTED] AND WAS STRUCK BY BULLETS DISCHARGED BY OFFENDER PLACING VICTIMS RADANOV AND HUGHES, WHO WERE ACTING IN THEIR OFFICIAL CAPACITY AS PARAMEDICS, IN FEAR OF RECEIVING A BATTERY. OFFICERS RETURNED FIRE STRIKING OFFENDER SIDI E. MOHAMED ABDALLAHI AND HE WAS SUBSEQUENTLY PLACED INTO CUSTODY. OFFENDER'S FIREARM RECOVERED. OFFENDER SUFFERED MULTIPLE GSW'S ABOUT THE BODY AND IS BEING TREATED AT ST. FRANCIS HOSPITAL.
